### **Research Grant Program Guidelines**

### Mission of the BCECM

Established at Memorial University of Newfoundland through a generous benefaction, the Bruneau Centre for Excellence in Choral Music BCECM) promotes research and community projects that seek to understand, encourage and enhance the powerful impact that choral singing can have on individuals and communities. The resources of the Centre assist in the realization of projects that have the potential to stimulate excellence in community music-making at local levels both across the province of Newfoundland and Labrador and on national and international levels. It is understood that, in accordance with the wishes of Drs. Angus and Jean Bruneau, funds may be disbursed in support of research and scholarship inside and outside the university community. Administrative support for this competition is provided through the School of Music.

### The BCECM supports research projects that fulfill our mandate, including:

- The encouragement and facilitation of theoretical and applied research, national and international in scope, on the dynamics of community music-making, with particular attention to choral and group singing.
- The support of networks and resources which can assist the researcher in furthering the discovery of new knowledge around the practice of choral and group singing in itself and in its societal roles.
- The dissemination of research results which provide theoretical and practical insight into choral and group singing and the community dynamics which grow from and around it.
- Support to commission, publish and disseminate new choral compositions and arrangements that speak universally through the singing traditions of Newfoundland and Labrador.
- Support for initiatives that will enhance choral music making at the University or College level in Newfoundland and Labrador.

Research is understood to encompass a full range of scholarship and critical, creative, professional, or developmental activity, including community engaged projects.

### How much money can I apply for?

The maximum amount is \$15,000.00. For grants requiring in excess of \$10,000.00, priority will be given to those that demonstrate support from other sources.

### Who can apply:

BCECM research grants are available to graduate students, postdoctoral fellows, and faculty members affiliated with Memorial University of Newfoundland. Projects that include research collaborators from other institutions are welcome, but the principle applicant must be affiliated with Memorial University of Newfoundland. Graduate student research must be conducted under the supervision of a qualified faculty member.

The application must be completed by the principle investigator who will take primary responsibility for the intellectual direction of the research and assume administrative responsibility for the funds. Grant funds are not intended to supplement the salary of the Principal Investigator or Co-Applicants; only research assistants may be paid salary from this funding. Graduate student research must be conducted under the supervision of a qualified faculty member

### **Eligibility of Expenses:**

BCECM research grants are designed to defray the normal direct costs of research including personnel costs, supplies and materials, equipment (to a maximum of \$1,500), technical assistance, research travel, and dissemination and communications.

### **Adjudication Process:**

Applications will be adjudicated by an Award Panel consisting of three faculty members from Memorial University and two members of the artistic community. Recommendations will be forwarded by the Awards Panel to the Board of Directors of the BCECM for their review and approval. It is anticipated that awards will be announced by December 1, 2023.

In the case of two applications of equal merit, where only one of them can be funded, preference will be given to an applicant who has not recently received BCECM funds as well as to those who have demonstrated consideration of <u>equitable project design</u> [pdf].

#### **Terms and Conditions:**

- 1. Only complete applications that arrive by the deadline will be considered.
- 2. All research grants fall under the regular protocols and policies for research grants held at Memorial University of Newfoundland.
- 3. Project start date must be after December 1, 2023 and will normally be completed within one year.
- 4. In order to hold a new BCECM grant, any previous BCECM-funded projects need to be closed.
- 5. Extensions: requests should be sent in writing to the Board with detailed reasons and proposed new timeline. A one-year extension may be granted at the Board's discretion.

### Reporting Requirements:

- 1. It is the award holder's responsibility to notify the BCECM Board of any deviations to the original proposal. **Any deviations over 10% in a given budget category require prior approval**. Should the scope, budget or timeline of your original proposal change, please submit a written request to the Board requesting a deviation 2–3 weeks in advance.
- 2. All research grants fall under the regular protocols and policies for research grants held at Memorial University of Newfoundland.
- 3. A full project report, including a detailed description of how the money was spent and what outcomes were achieved, is due to the BCECM within **60** days of the completion of the project.

4. A brief of this research, its outcomes, and/or findings designed for publication on the BCECM website should be submitted with the final report. Please include publication and/or contact information for anyone interested in further exploration of the research findings.

### **Application Process:**

Applications should be completed using the attached application package submitted to the Bruneau Centre for Excellence in Choral Music to arrive by or on the published deadline.

- o Supporting materials (if applicable)

All information requested on this form is collected under the authority of the Memorial University Act (RSNL 1990 Chapter M-7), and is needed solely for the administration and management of your Bruneau Centre for Excellence in Choral Music research/project application.
