He is also a director of Brookfield Asset Management, Great-West Lifeco., United Way of Calgary, the Pension and Compensation Committee of the Calgary Stampede Board, and a governor of the Canadian Association of Petroleum Producers. Mr. Coutu has more than 25 years of experience in the resource and energy sector, primarily focused in corporate finance.

Prior to joining Canadian Oil Sands, Mr. Coutu was chief financial officer of Gulf Canada and preceding that, he was senior vice president international and vice president of finance at TransCanada Pipelines. He has also worked in the upstream oil sector for Hudson's Bay Oil & Gas and Dome Petroleum, and has five years of experience in the investment banking business, mostly with Burns Fry Limited. Mr. Coutu has completed the Institute of Corporate Directors, Corporate Governance program and is accredited as a certified director under that program with the ICD.D. designation.

Mr. Coutu holds an H.B.Sc. in geology from the University of Waterloo (1976), an MBA from the University of Western Ontario (1980), and is a member of the Association of Professional Engineers, Geologists and Geophysicists (APEGGA).
