
Memorial University of Newfoundland Research Support Fund Report 2017-18

The grant provided through the Government of Canada Research Support Fund (RSF) is essential to Memorial's research success. Funding is allocated among a variety of activities that support the research enterprise. In 2017-18, Memorial received \$4,468,744. The distribution of this funding is outlined in the chart below.
