

I am forwarding to you the Final Action Plan for the Folklore Department which has gone through a discussion process with the Head, Dr. Martin Lovelace and through him, the Department of Folklore. As the Academic Program Review unequivocally states, it is a flagship department at Memorial University, with a sustained international reputation for excellence in teaching (both at the undergraduate and graduate levels – a preferred destination for doctoral students, particularly international students), research (combining regional research with theoretical and conceptual frameworks underlining the international folklore studies discipline) and service. This collegial department has the strongest commitment to its discipline, to its students and to the community at large. However, there are two points of concern: a total absence of funded research and limited physical facilities constraining the department's future growth.

In order for the department to maintain its superlative status within the North American scholarly community, it is imperative that the faculty within the department apply for and seek external funding to support its graduate students. As the funding for doctoral students becomes more competitive across Canadian and North American universities, the department will need to offer higher financial incentives to its incoming doctoral students. I have discussed this issue with Dr. Lovelace and have asked him to ensure that the new tenure track faculty hired in the department apply for external funding and encourage his other colleagues to do so. The second concern relates to space requirements for the department. The future growth of the department is subject to the availability of space. And we must ensure that this excellent department grows. In order to deal with the space issue, I, with the approval of the department, have begun a discussion with the Director of Libraries to consolidate all archives (four collections, including that of Folklore) under one roof. This consolidation would require a new space and I believe one of the most appropriate ways to secure it is to have this as the top priority in the university's effort to secure funding from donors. This consolidation will free up some very valuable space to allow the growth of the Folklore Department – for both its faculty and graduate students. $\| \| = \int n$
