The School strives to enrich its teaching, research, and scholarship through the contributions of individuals from diverse backgrounds. In keeping with CASWE Standards for Accreditation, the mission of Memorial University, and the mission, vision and values of the School of Social Work, the School embraces equity, inclusion, and accessibility.

Ten percent of seats each year will be allocated to Indigenous applicants who meet the admissions criteria as outlined in the University Calendar. An additional 10 percent of seats will be allocated to persons from equity-deserving groups (e.g., disability, race, ethnicity, gender identity, sexual orientation, and socio-economic status) who meet the admissions criteria as outlined in the University Calendar. If these seats are not filled, they will be allocated to other applicants as per the priority list for admissions.

Applicants meeting admission criteria, as outlined in the University Calendar, shall be selected based on the following priorities:

1. Newfoundlander/Labradorian applicants who are of Indigenous ancestry and/or of diverse identity including: disability, race, ethnicity, gender identity, sexual orientation, and socio-economic status.
2. Newfoundlander/Labradorian applicants (the definition of residency is available [here](#))
3. Out of province applicants who are of Indigenous ancestry and/or of diverse identity including: disability, race, ethnicity, gender identity, sexual orientation, and socio-economic status.
4. Out of province applicants.
