Failure to submit all supporting documents in the online application on or before the application deadline will result in the application being deemed incomplete and, therefore, will not be considered for admission. Incomplete application files will not be reviewed.**

**II. EDUCATIONAL EQUITY**

The School of Social Work acknowledges institutional processes and cultural differences may present

barriers to applicants in gaining equal access to educational programs. The School strives to enrich its teaching, research, and scholarship through the contributions of individuals from diverse backgrounds with different attributes. In keeping with CASWE Standards for Accreditation, the mission of Memorial University, and the mission, vision and values of the School of Social Work, the School embraces equity, inclusion, and accessibility.

Ten percent of seats each year will be allocated to persons of Indigenous ancestry who meet the admissions criteria as outlined in the University Calendar. An additional 10 percent of seats will be allocated to persons from equity seeking groups (e.g. disability, social class, sexual orientation, gender identity, race and ethnicity) who meet the admissions criteria as outlined in the University Calendar. If these seats are not filled, they will be allocated to other applicants as per the priority list for admissions.

Applicants meeting admission criteria, as outlined in the University Calendar, shall be selected based on the following priorities:

1. Newfoundlander/Labradorian applicants who are of Indigenous ancestry and/or of diverse identity including: social class, sexual orientation/gender identity, race, or ethnicity.
2. Newfoundlander/Labradorian applicants;
3. Out of province applicants who are of Indigenous ancestry and/or of diverse identity including: social class, sexual orientation/gender identity, race, or ethnicity.
4. Out of province applicants.

### III. APPLICATION FORM

Please ensure all questions are answered on the online application. The online application and all supporting documents must be submitted to the School of Graduate Studies at [www.mun.ca/become/graduate/apply](http://www.mun.ca/become/graduate/apply) (not to the School of Social Work) on or before January 15. For more information on the application process, please visit [www.mun.ca/become/graduate/](http://www.mun.ca/become/graduate/).

The on-line application requires a Statement of Interest indicating your reasons for wanting to enter the School of Graduate Studies at this University and stating your research interests and objectives. The School of Social Work requires that this Statement of Interest also be submitted in PDF format.

The **Statement of Interest** is an opportunity to discuss why you are interested in completing an MSW at this time at Memorial University, what you bring to the MSW program, and what you hope to take from the program. You may wish to comment on your social work practice and learning

opportunities/professional development since completing your BSW. If you have identified as Indigenous or as a member of an equity-seeking group, you might describe how this has shaped the unique circumstances for which you require equity consideration in the admission process. Keep in mind that you are shaping an impression of who you are. Be sure to “paint” an informative picture.

Finally, if you are interested in the course route, please discuss your practice focus interest. If you are interested in the thesis route, please discuss your proposed topic for research.

#### **IV. RESUME (REQUIRED)**

**In addition to providing your resume in the online application, the School of Social Work requires your current resume in PDF format.**

Your resume should include work experience, educational background, field internships, research projects, professional development, volunteer experience, certifications, awards, affiliations, publications, and other information you consider relevant. In the section pertaining to **paid** employment history, please include for each position: Title(s) of Position, Date of Employment, Type of Employment (full-time, part-time, and number of hours per week), Agency/Organization, Description of Professional Duties, and Total Number of Years/Months worked.

**Please keep in mind that your resume tells the Admissions Committee members who you are. Ensure it conveys the impression you wish to make.**

#### **V. LETTERS OF APPRAISAL**

**As part of the online application, the School of Graduate Studies will email appraisal forms directly to the referee after the application is submitted and processed.**

Applicants must provide two letters of appraisal. One referee must assess the applicant’s previous academic performance and one must assess the applicant's professional social work practice performance. Letters of appraisal are submitted directly to the School of Graduate Studies via email by the referees.

It is strongly recommended that applicants ask referees, particularly those assessing professional social work practice performance, to include in their letter of reference an assessment of the applicant’s suitability to undertake graduate education. This should include ability, motivation, strengths, areas needing improvement, ability to cope with stress, ability to work collegially and to communicate effectively, reflecting values as relevant to the profession, as well as, any additional comments.

As with your Resume and Personal Statement, referees help give the Admissions Committee a picture of your background and the quality of your experience. You need to keep this in mind as you choose your referees.

## VI. ACADEMIC PERFORMANCE ASSESSMENT

Applicants are required to complete the Academic Performance Assessment, as described below. Failure to do so on or before January 15 will result in the application being deemed incomplete and, therefore, not considered.

Applicants must have achieved an average of at least 70% in the courses comprising the last sixty (60) undergraduate credit hours completed up to and including the fall semester prior to the date of application.

- All courses comprising the last sixty undergraduate credit hours, including field internships, are included in the academic assessment.
- The University calendar and/or the back of the transcript from each university will indicate number of credit hours per course and the translation of letter grades to numeric grades (expressed as a percentage). Where letter grades represent a range of numeric grades, the middle of the scale is to be used in calculating the applicant's average. (Typically, a one-semester course is 3 credit hours, and a two-semester course is 6 credit hours.)
- Courses graded as pass/fail are included in the academic assessment; however, they are not counted in the calculation of the applicant's average.
- In the event that there are more credit hours than needed in the earliest term included in the Academic Assessment, the average for that term will be used as the grades(s) for the necessary course(s), as opposed to selecting individual grades.
- Failing grades are included in the academic assessment and in the calculation of the applicant's average.
