

## **Teaching Term Appointment: Department of Geography**

Memorial University of Newfoundland's Department of Geography is seeking applicants for a **9-month teaching term appointment** during the Fall 2023 and Winter 2024 semesters. Contract begins August 1 and on-campus teaching duties commence with the 2023 Fall semester.

The minimum qualification for teaching term appointments is normally a completed doctoral degree in Geography or cognate discipline. In exceptional cases, PhD candidacy and/or a master's degree in Geography or cognate discipline, together with appropriate teaching experience, may be an acceptable qualification. The successful candidate will teach the following course configuration during the 2022-2023 academic year:

Fall 2023:

Geography 1050 (Geographies of Global Change)—2 sections Geography 2302 (Economic Geography)

Winter 2024:

Geography 1050 (Geographies of Global Change)—2 sections Geography 2302 (Economic Geography)

All teaching is anticipated to take place on campus unless otherwise indicated. The courses and delivery modes offered in the contract are subject to change based on the operational needs of the department. The department will support instructors with some shared outlines and course materials.

## **Calendar descriptions:**

**1050 Geographies of Global Change** provides perspectives on the major geographical challenges and changes facing the contemporary globe, including: climate and environmental change, sustainability, human development, economic globalization, cultural change, and population and migration. Using the integrative skills of geographical analysis, the course prepares students for advanced study in geography and citizenship in the modern world. **2302 Issues in Economic Geography** covers issues and ideas in economic geography. The development of local, regional and global economies will be related to economic, cultural and resource factors at international scales. Candidates who are engaged in critical geography studies and pedagogy aligned with areas such as feminist political economy, Indigenous geographies, Black geographies, queer ecology, or similar justicebased and community-serving research and teaching are encouraged to outline them in their applications. In assessing applications, Memorial recognizes the legitimate impact that leaves (e.g., parental leaves, leave due to illness) can have on a candidate's record. These leaves will be taken into careful consideration during the assessment process.

Salary and benefits are determined by the Memorial University of Newfoundland Faculty Association (MUNFA) Collective Agreement, Article 22 and Appendix D.1 (Lecturer; salary floor Sept 1, 2023 set at \$70,970 per annum).
