Background to Forum

The Atlantic Provinces Transportation Forum (APTF) is an annual event held with the objective of discussing regional transportation issues. Residual funds from the Atlantic Provinces Transportation Commission (APTC) are held in trust to support this event. The conference rotates among the University of New Brunswick, Dalhousie University and Memorial University.

The concept of an Atlantic Gateway as a distribution port linking markets and suppliers in the Far East and Europe with those in eastern North America has been the subject of a number of studies including those carried out by the Atlantic Provinces Economic Council (APEC), by the Asia Pacific Foundation, by the Atlantic Institute for Market Studies (AIMS) and by Intervistas (for ACOA). Most of the attention has been upon Halifax as the principal Atlantic Gateway. The time has now come to examine how such a Gateway will affect individual Provinces and the planning of their transportation systems.

Purpose of Forum

The Atlantic Provinces Transportation Forum (APTF) has as its objective to examine the impact of the proposed Atlantic Gateway on the future planning of transportation systems in the Province of Newfoundland and Labrador, particularly the marine connections between the Province and the mainland of North America. The Forum will address the transshipment of goods for further shipping to North America and for backhaul to the East, as well as the Province's own requirements, in the light of economic and demographic changes which are reducing overall population and concentrating it on the Avalon Peninsula. The Forum is intended to launch a serious examination of major transportation issues facing the Province and to identify an agenda for future action to develop constructive solutions.

The key questions to be addressed by the Forum will be as follows:

- What are the opportunities for this Province from an Atlantic gateway?
- What transportation solutions will improve the Province's competitive position?
- What action needs to be taken as a result of this Forum?
- What public policy research is needed to identify transportation options and solutions?
 - What role can Memorial University and the Harris Centre play in finding constructive solutions?


