## **Conference Leave Guidelines**

- Residents are entitled to <u>seven (7) days of paid leave</u> in each academic year to attend conferences, including online conferences.
- Required travel days are part of the conference leave allotment. One (1) travel day before and one (1) travel day after the conference is permitted. Travel must occur on the day directly preceding the first day of the conference and the day directly following the last day of the conference. Any additional travel days will have to be taken as vacation days.
- Generally, conference leave will not be granted to complete online courses.
- You cannot carry conference leave days over from one year to another.
- A request for conference leave must be substantiated by appropriate documentation, verifying the dates of the conference and related travel.

Residents must ensure that all professional and call responsibilities are covered during this time. In addition the, appropriate administrative staff/resident, clinics, coordinator and/or supervising preceptor should be notified as necessary.
