Primary Health Care Framework NL

Primary Health Care Reform is in various stages of implementation across all the Canadian Provinces and territories. The Government of Newfoundland and Labrador published "Healthy People, Healthy Families, Healthy Communities: A Primary Health Care Framework for Newfoundland and Labrador 2015-2025. This included four goals and objectives to guide action:

- Goal 1: Engaged individuals, families, and communities sharing responsibility for health promotion, illness and injury prevention, early intervention, and self-management
- Goal 2: Individuals and families attached to a collaborative primary health care team
- Goal 3: Timely access to comprehensive, person-focused primary health care services and supports
- Goal 4: Connected and coordinated services and supports across the health and social sectors

Education

Family Medicine education in Canada occurs on both undergraduate and postgraduate levels. New initiatives in strengthening and supporting the involvement of family medicine in the undergraduate curriculum has paid dividends in an increase in interest in family medicine as a career in recent years. Opportunities for family medicine residency training however have not reached the CFPC's stated goal of 50% of all residency seats across the country. On the postgraduate level the College has moved to competency-based training and is promoting innovation in resident assessment linked to this.

Other Disciplines of Family Medicine

All the Disciplines of Family Medicine across the country were contacted and websites reviewed. A total of 8 Strategic Plans were retrieved and reviewed. Common themes identified included a call for innovation, collaboration, leadership, community engagement and partnerships and excellence in research, education and patient-centred comprehensive clinical care.
