1. Major Curricular Changes	Move to change Blood flow and Oxygenation theme from Phase 2 to Phase 1 for the Class of 2024. In order to accommodate this change, it is being move Infections and fever to beginning of Phase 2. Amanda Pendergast approved this motion. No objections.

Biochemistry has been sequenced and is fitting better
together. The Biochemistry UCLs are proposing to
add a new session called Proteins and Diagnostic
Testing. The second addition they are proposing is to
bring back the Introduction to the Endocrine System
lecture. This is a one hour session It was previously in
the curriculum but was taken out last year. For
Carbohydrate Metabolism II and Nucleotide
Metabolism, they are asking to increase from 1 hour
to 1 ½ hour session. Previously these two lecture
were 1 $\frac{1}{2}$ hours but was reduced to 1 hour. It was felt
that they really need 1 ½ hours to deliver the content.
Removing content: they are proposing to reduce the
Introduction to Metabolism from 1 ½ hours to 1 hour.
With the addition of the Introduction to the
Endocrine System the full 1 ½ hour isn't needed for
this lecture.
The last changes for Biochemistry would be moving
content to a different Phase. It is being proposed
that these three lectures: Cholesterol Metabolism,
Lipid Serum Profiles, and Amino Acid Biosynthesis is
moved from Phase 3 into Phase 1.
Alison Haynes moved to have the Biochemistry
changes approved.
No objections
Embryology: they were requesting that there could
be a reduction in Early Embryonic Development
lecture from 1 ½ hour to 1 hour.

Alison Haynes moved to approve that change. No objections.	
Histology: removal of content. There was a combination of the Cardiovascular and Lymphatic Histology lectures combined into one lecture that was 1 ½ hours. In the whole curriculum it is about a reduction of 30 minutes. They also want to move the lab that is associated with Respiratory and Lymphatic Histology to Phase 2.	
Alison Haynes moved to approve those changes. No objections.	
Immunology: they are proposing to join two lectures together. The Function and Structure of Antibodies combined with Immunogens and Antigens for a 1 hour lecture. That would be a reduction of one hour in the curriculum. There was an Antibody Diversification independent learning module that was offered. It was felt that this material was too extensive for what the medical students need to know. So they are proposing to have that removed. There were two separate tutorials, one for Hypersensitivity Reactions 1 and the other for Type II and Type III. They are suggesting that these two can be combined into one two-hour tutorial. This would be a reduction of 30 minutes in the curriculum. The last change is to remove Primary immunodeficiency tutorial that was previously done. The tutorial had been restructured and is quite redundant with one of

the lectures. The last change is the addition of one session called The Development of the Lymphocytes. That is to cover off some of the remaining objectives	
that came from the joining of the two lectures.	
Alison Haynes moved to have the Immunology changes approved. No objections	
Some of the Pathology, Pediatrics and Pharmacology changes were to make room for moving content into Phase 1 into the Blood Flow and Oxygenation theme. It is being proposed to move the Neoplasia lectures that occur by Pathology into Phase 2. The Primary Immodeficiency lecture done by Pediatrics can be in either Phase 1 or Phase 2. But to make room in Phase 1 it is being proposed to move it into Phase 2 in the Infections and Fever theme. Similarly with the Pharmacology, they have three lectures that were in Phase 1: Adverse Drug Reactions and Therapeutics I and II. This movement is to make room as well as feedback received from faculty and the learners that it is probably best placed later in the curriculum.	
Alison Haynes moved to have those changes approved. No objections	
Physiology: the Biochemistry group felt that one of the pieces missing was the Introduction lecture to Physiology. COWG also agreed. So they are proposing to add a two-hour lecture into Phase 1.

	This would be in the Foundation theme. They previously had two separate lectures, one for Skeletal Muscle and the other one is for Cardiac and Smooth Muscle. They think those lectures are suited to be done together. They are proposing that it be done in Phase 1.

	Rheumatology: there were three lectures, Myositis, Lupus and Vasculitis. To make more space as well as feedback that those lectures are best offered later in the curriculum, it is being proposed to move those lectures out of Phase 1 and into Phase 3 for the incoming year.

5. Other Faculty Issues	There are issues with learning how to deliver remotely. There have been sessions on how to deliver online material.	
6. Other Student Issues	Everything is good for now. Everything will need to be explained to the new first year class without being able to meet in person. The class of 2023 will try to meet with the class of 2024.	
7. New Business	Assessment plans have been done for 5710 presuming returning to lass. There is time to adjust between now and July 31. There will be four exams. Learners must pass three out of four to pass. The consequences of a failed grade are in the MUN calendar. Lifelong learning has moved to Physician Competencies. Course description has changed and there is new language. The weighting of the exams is fairly even. Someone who passes but barely can fail, i.e. has to reassess every exam. 5720 clinical skills – is subject to what will happen. May need to change. There are no significant changes re: paragraph regarding consequences of a failed grade. 5730 physician competencies No changes. The course description was revised. Leadership modules have been moved into the Physician Competencies block. Weighting is adjusted.

The leadership certificate is option after the MD program. Criteria for completion is to pass each block. The due dates for Biostats are not included. Diana will check before UGMS and handbook for Dec 10 and 17.	
Natalie – Shree Mulay's session is on December 16 but it needs to be scheduled earlier. The research proposal is on Phase 2 and the question is in Phase 1. Natalie will email Katrin Zipperlen and Jacqueline Costello re: selecting topcs in Phase 1. It is not assessed so it's not on the assessment plan. Research pillars is in the first week of Phase 1. The number of assignments for lifelong learning has been reduced from two to one.	
5740 Community Engagement has two assignments, one for Community Health and one for Early Clinical Experience. There are no changes for the criteria for completion.
