In the new peer assessment process students use a SAS approved professionalism scale to assess peers. The students report they prefer the new summary of peer assessments over the previous collection of individual reports. Katrin Zipperlen reviews all feedback and edits feedback into summary reports. Dr. Kenny reviews any reports that are flagged as a concern before students receive the reports. The majority of feedback is positive. Students state they do feel somewhat uncomfortable assessing their peers. The smaller clinical skills groups in Phase 2 make giving anonymous feedback more challenging. This process gives students an opportunity to practice giving constructive feedback.

4.5. Physician Competencies	4.5.1. Research Day Research day was a success. There are however outstanding issues related to Ethics applications. Approximately 42 students submitting ethics applications. This process will be very taxing on Ethics board. Dr. Kenny has made UGMS aware of this issue. A discussion on alternative research activities was held. One alternative suggested was to encourage students to complete systematic reviews and meta-analysis.
