1. Phase 4 Prep	Jasbir has stepped in as the lead for Phase 4 Prep for now. Phase 4 prep is scheduled June 15 – 26, 2020. Jasbir did a canvas to get a sense of what can be done online. Some components can be done virtually. MedCareers and CaRMS Prep can be done online. The Preparation for Ward Workshop can have an online didactic session with some notes. The workshop review cases is not possible online. BCLS can only be done hands on. Some of NRP can be done online but will still need one day in person before starting Phase 4. Suturing can be added later
