Objectives

[Medical expert]

- Demonstrate the ability to assess and manage common and important clinical problems in the area of obstetrics and gynecology. [Medical Expert 2 & 3]
- Demonstrate the ability to obtain an obstetrics and gynecologic history. [Medical Expert 1]
- Demonstrate the ability to perform an obstetrical and gynecological examination, including a complete pelvic examination and recto-vaginal examination. [Medical Expert 2]

- Develop a management plan including (a) laboratory and diagnostic studies and their interpretation, (b) treatment options and the risks and benefits, (c) continuing care plan. [Medical Expert 3]
- Demonstrate competency in basic procedural skills related to obstetrics and gynecology. [Medical Expert 3]

[Communicator]

- Communicate effectively with patients and their families. [Communicator 1]
- Demonstrate effective oral and written information about a medical encounter. [Communicator 5]
- Demonstrate ability to present a patient's case in a clear, concise and complete manner. [Communicator 3]
- Communicate relevant information and explanations effectively and accurately to patients and their families, colleagues and other professionals. [Communicator 3]
- Ensure women have given informed consent before conduction and/or being present for examinations or procedures. [Communicator 1]

[Collaborator]

- Participate effectively and appropriately in an inter-professional health care team. [Collaborator 1]
- Demonstrate knowledge of other resources available to women when providing obstetrical and gynecological care. [Collaborator 2]
- Demonstrate respect for the patient's primary care provider by ensuring they are informed about the patient's care plan. [Collaborator 3]

[Manager]

- Demonstrate appropriate and cost-effective use of investigations and treatment. [Manager 2]
- Develop an understanding of the organizational skills involved in managing patients and patient flow. [Manager 2]
- Develop an understanding of factors contributing to resource issues in services delivering care to obstetrics and gynecology patients. [Manager 3]

[Health Advocate]

- Respond to individual women's needs and issues as part of their care [Health Advocate 1]
- Understand the health needs of the community. [Health Advocate 1]
- Identify the determinants of health of the population of women that are served by the health care system. [Health Advocate 1]
- Understand the methods to promote the health of individual women, communities and populations. [Health Advocate 1]

[Scholar]

- Critically appraise the literature relevant to obstetrics and gynecology and apply appropriately to patient care. [Scholar 2]
- Facilitate the learning of patients, families and other health professionals as appropriate. [Scholar 3]

[Professional]

- Demonstrate a commitment to patients, the profession and society through ethical practice. [Professional 1]
- Attend scheduled and assigned teaching and clinical responsibilities in a timely fashion. [Professional 1]
- Communicate to the appropriate people when not able to attend scheduled assignments in a timely fashion. [Professional 1]
- Recognize and accept limitations and know when to ask for help. [Professional 1]
- Protect patient's information, keeping it confidential and disclosing only with the patient's permission except when required by law. [Professional 1]
- Be reliable and responsible in fulfilling obligations. [Professional 1]
