1816 8 nov cb surr ct Mich of colliers and his wife had writ for 53/18/2 agst
them by thos danson mcht. they obstructed (he with gun) wife with a pew
robt connell constable in attaching their property. he could
not find security for peace and was confined to gaol
11 nov. he found L500 security to appear next money and was releaseed

1816 18 nov cb surr ct Mich (see above) found two sureties L100 each jas corcoran
and geo gushoe for him to keep the peace.
considering HIS ADVANCED AGE this all that was done.

1816 18 nov hg surr ct mich sued by robt connell b/f considering his advanced age
bound him over only

CULLEN

1816 22 5 dec hg surr ct Mich of colliers resided robt connell constable in
serving writ of execution of thos danson for 53/8/2. pointed a gun
at him. could not find security to keep peace-jailed.

1817 29 sep hg surr ct writ agst mich of colliers 42/7/9 by rich anderson

27 may SUEd jas gushoe for L25 for damage to his stage caused by gushoes
schr this spring arbitrated. 3 jun awarded 3/10/-

resisted execution. jailed.

constable ~~tried by jury~~ true bill found by grand jury
pleaded not guilty he resisted execution of foreclosure writ on
his property given up to chas cozens(happened last december)
found(suprisingly) not guilty

1820 27 may hg ~~surr~~ sup ct MICH Sued by chas cozens for foreclosure of 1815 mortgage
on his plan at colliers for L113 debt(now total L183.
PLANT TO BE SOLD for benefit of creditors(cozens first) HE INSOLVENT?
