WINDING

The examination of Thomas Leg, dated the 10th of March, 1763. He was born in Cadstock, Dorset. He was a bastard child, born of Hanna Leg and a person named Charles Curtis, Inn-holder. They said Charles Curtis took him from his mother at about three months, and provided for him until he was ten years of age, at which time he bound him apprentice to Arthur Culm of Cerne Abbas in Dorset, to learn the art of planting in Newfoundland. Accordingly he went to Newfoundland where he served about six months his head master, Arthur Culm, who died. He was then assigned over to Elick Bridford, partner to Arthur Culm, to James Gill by his own consent, a planter in Newfoundland, but belonging to Exeter in Devon with whom he served five years, or thereabouts, when his master failed and ran away. But before he ran away without the knowledge of this examinant, he consigned him over to John Gallabois, a Frenchman, then residing in Newfoundland, whom he served about eight months when he escaped from the said service on board his majesty's ship of war, called the Arundel in which ship he returned to England. He then returned to his mother at Cadstock, his father refusing to do anything further for him. He stayed half a year, then went to Weymouth and hired himself a servant by the year. But lived in his place but three months, but then went to sea in the merchant service in which he has continued ever since. About three years since, he married Mary, his present wife by whom he has no child.
