Nominations are now being received and will close July 3<sup>rd</sup>. The second MUNPA scholarship was awarded in December while the fund is continuing to grow.

Members of the Services to Members Committee, both in St. John's and Corner Brook were commended for the program of events that was put into place during the past year.

Communications remain a challenge, with email addresses for some 600+ members not on file with the Association. In order to contact all members, the Board has decided to mail out two issues of *Your Voice* each year, the first at MUNPA expense, the second accompanying a Human Resources mailing of health benefits information. MUNPA is very appreciative of HR support in this area.

Free parking in lots 16/16A is no longer available following commencement of site preparation for the new Science building. New parking policies are under development. MUNPA will keep members informed through *Your Voice*.

Bob thanked Board members and Gwyn Barrowman for their support during his term as President of MUNPA; his term ends with appointment of new Board.
