Public Involvement in Choosing Health Policy Priorities

Should a new and expensive but experimental drug be funded by the province? How do we decide what program, treatment or medication to trade off to pay for this new drug? What is the best way to spend our limited healthcare dollars?

Amid rising expectations about what the healthcare system can and should provide, decision makers are addressing these difficult questions on a daily basis. How can we ensure that we make ethically sound decisions that are economically sustainable and reflect public values? Should the public be more involved in making these types of decisions?

Dr. Roger Chafe, Director of Pediatric Research and Assistant Professor in the Faculty of Medicine at Memorial, has co-authored an article on this topic that was recently published in the <u>Canadian Medical Association Journal</u>. In his article, Dr. Chafe points out that there are few successful examples of public engagement in setting health priorities in Canada, and in many cases, the act of public consultation has been a token exercise. Dr. Chafe argues that "Providing more opportunities for public involvement and clearly reporting how input is used would reduce public cynicism. More importantly, we would add a legitimate new voice — that of the public — to aid in making difficult choices."

Dr. Chafe, with colleagues at NLCAHR, Eastern Health, and the Department of Health and Community Services, has received a grant from the Canadian Institutes of Health Research to look at research on the use of deliberative processes and citizen engagement in making decisions around high-cost pharmaceutical therapies. The team will hold a workshop in October to discuss the issue with key research experts and health system decision makers. In conjunction with the workshop, NLCAHR will also host a CIHR Café Scientifique in an effort to get the public involved in this important discussion. <<<<Ple><<< Please see the sidebar for details.
