

**Memorial University of Newfoundland
Pedestrian/Driver Safety Contest (#MUNRoadRewards)
RULES AND REGULATIONS
2016**

1. OVERVIEW:

Contest administered by representatives of Memorial University of Newfoundland's Marketing and Communications (the "Contest Administrators"). Contest runs from 8 a.m., (NST) March 2, 2016, to 12 p.m. (NST) April 1, 2016, ("Contest Period"). No purchase necessary. Chances of winning depend on the number of entries received. Winner must correctly answer a skill-testing question. One entry per person.
