EXTENSION OF DEADLINE

TO: All Eligible Members of the Academic Staff in the Constituencies of Engineering and Applied Science, Grenfell Campus – School of Fine Arts, Humanities and Social Sciences, Marine Institute, Medicine, Music, and Pharmacy

SUBJECT: Senate Elections, 2020-2021

This is further to my memorandum dated January 31, 2020, requesting nominations by February 21, 2020, for candidates to fill vacancies on Senate. That deadline has now passed, and we are seeking further nominations for candidates to fill the following vacancies on Senate for a period of three years commencing September 1, 2020:

Engineering and Applied Science	2
Grenfell Campus – Fine Arts	1
Humanities and Social Sciences	1
Marine Institute	2
Medicine	3
Music	1
Pharmacy	1

In view of this, the Committee on Elections and Committees has agreed that the deadline for receipt of nominations be extended until **March 10, 2020**. The nomination forms should be returned to the Office of the Secretary of Senate by email (senate@mun.ca) or delivered to the Arts and Administration Building, Room 2002. Please note if nominations forms are sent via mail, they must be received by the Office of the Secretary of Senate no later than the deadline.

The Committee on Elections and Committees has also agreed to elect by acclamation the following candidates, nominations for whom were received by the deadline date:

Candidates for Senate Elections must be nominated by two qualified electors with the consent of the nominee. At least seven weeks prior to each annual Senate election the names of such nominees must be forwarded to the Secretary of Senate who will arrange for an online election to be conducted and electors shall have at least 14 days to cast their ballot.

Those entitled to vote are:

- (i) All full-time members of the academic staff of the constituencies who are either tenured or beyond their first year in the University shall be eligible to be electors.
- (ii) All full-time members of the academic staff at the Marine Institute as defined in items (a) and (b) of the Constitution of the Academic Council and section 1.1 of the By-Laws of the Marine Institute who are either permanent or temporary and beyond their first year in the Institute shall be eligible to be electors.

Those eligible for election are:

- (i) All full-time members of the academic staff of the constituencies who are tenured or permanent (exclusive of any person who is an ex officio member) shall be eligible for election.
- (ii) All full-time members of the academic staff of the Marine Institute as defined in items (a) and (b) of the Constitution of the Academic Council of the Marine Institute and section 1.1 of the By-Laws of the Marine Institute who are permanent (exclusive of any person who is an ex-officio member) shall be eligible for election.

The following are not eligible to be electors (or to be elected) in any constituency:

- Sessional lecturers
- Visiting lecturers
- Visiting professors
- Professors Emeriti
- Part time professors
- Academic staff members on leave without pay

The following are not eligible to be elected in any constituency (but may be electors):

- Ex-officio members of the Senate

As a point of clarification, ASM-CEs are eligible for election.
