80. MINUTES

An addendum to the Minutes of the meeting held on February 10, 1998 and the Minutes of the regular and special meetings held on March 10, 1998, were taken as read and confirmed.

## 81. REPORT OF THE COMMITTEE ON HONORARY DEGREES AND CEREMONIAL

### 81.1 Honorary Degrees

The names of two candidates recommended by the Committee on Honorary Degrees and Ceremonial were presented to the Senate for awarding of doctoral degrees honoris causa. Dean Bowmer and Professor Fowler each made a brief statement about one candidate. Members were given the opportunity to discuss the merits of the candidates before voting. Upon voting by a show of hands, each candidate was approved by at least a two-thirds majority vote.

### 81.2 Nominations for the Status of Professor Emeritus

Four names were recommended by the Committee on Honorary Degrees and Ceremonial for the award of the title of Professor Emeritus. Senators were given the opportunity to discuss the merits of each of the candidates before voting. Upon voting for each candidate individually by a show of hands, all four candidates were approved for consideration by the Board of Regents by at least a two-thirds majority vote.

### 81.3 Re-Appointment of Public and Deputy Public Orator

A memorandum dated March 25, 1998 was received from the Committee on Honorary Degrees and Ceremonial recommending that Professor Shane O'Dea be re-appointed as Public Orator and Dr. Annette Staveley be re-appointed as Deputy Public Orator for a period of three years commencing on May 1, 1998.

It was agreed that this recommendation be approved.

### 81.4 Academic Dress Hood Colours

A memorandum dated March 15, 1998, was received from the Committee on Honorary Degrees and Ceremonial recommending
that the colour "Moss Green" be approved as the hood colour for the Bachelor of Technology degree.

It was agreed that this recommendation be approved.
The Committee on Honorary Degrees and Ceremonial also recommended to Senate that the authority for approval of hood colours be delegated to the Committee on Honorary Degrees and Ceremonial based on the frequency of such requests of late, the short turn around time needed for approval, as well as the perfunctory nature of these requests after the colours have been selected by the academic units.

It was agreed that this recommendation be approved.

## "H) SPECIFIC PROGRAMMES

## 4.Post-Secondary Studies

The graduate programme in Post-Secondary Studies is designed to prepare candidates to function in a variety of roles in informal and formal post-secondary learning environments (including academic, technical, professional, adult education, and student services/development). It facilitates a study of the post-secondary educational system through an examination of its foundations, directions, organization and administration; and through curriculum and instructional development options for occupational preparation and adult education.

## Admission Requirements

In addition to meeting the requirements in the general degree regulations,
i) candidates must have completed an undergraduate course in statistics (E2900 or the equivalent); at least 3 credit hours in adult learning (E2801 or the equivalent), and 3 credit hours in postsecondary education (E2720 or the equivalent).
i) candidates must normally have a minimum of two years of successful experience in working with adult learners.
iii) Candidates for the Master of Education (Post-Secondary Studies) shall be required to complete courses in the following areas that form the programme core.

* E6100 Research Designs and Methods in Education (3 credit hours)
* E6801 Foundations of Post-Secondary Programmes (3 credit hours)
* E6802 Adult Learning and Development (3 credit hours)
* E6803 Research in Post-Secondary Education (NEW) (2 credit hours)

Students on the thesis route shall be required to successfully complete not fewer than 7 credit hours from H.4(c) in addition to those required in H.4(b) for a total of at least 18 credit hours.

Students on the internship, project or paper folio route shall be required to complete not fewer than 7 credit hours from H.4(c) in addition to those required in H.4(b) and at least 6 credit hours may be taken from other graduate offerings within the Faculty, the University, or other universities, as required for individual student programmes for a total of at least 24 credit hours.

[^0]Courses must be appropriate to the programme and chosen in consultation with the advisor."

82.4 Instrumental Analysis (Chemistry) Programme

At a meeting held on November 28, 1996, the Executive Committee of Senate considered a proposal for a Master of Instrumental Analysis (Chemistry) degree programme.

The Executive Committee requested, that before forwarding the proposal to Senate, clarification be sought with regard to concerns which were raised in the report of the Review Committee, and that an assurance be received of resolution of these concerns.

A memorandum dated March 25, 1998 has now been received from the Dean of Graduate Studies advising that the answers to these concerns have been provided in two memoranda dated March 25, 1998 from the Head of the Department of Chemistry.

Dr. Lucas, Head, Department of Chemistry, advised Senate that the funding for the new programme will come from three main sources, i.e. federal, provincial and commercial, but that this funding is dependent upon approval in principal of the programme by Senate.

In forwarding this proposal to Senate, the Executive Committee also noted that since the Master of Science degree regulations were modified on January 13, 1998 to include either a thesis or a project and report, it recommends that this programme be a major within the Master of Science degree.

It was moved by Dr. Kealey, seconded by Dr. Lucas and carried that following programme and associated calendar changes be approved:

Page 425, 1997-98 Calendar, following the heading Chemistry, amend Clause 1. to read as follows:
"The degrees of Master of Science in Chemistry and Instrumental Analysis are offered as full-time or part-time study."

Following Clause 6. insert the following:
"INSTRUMENTAL ANALYSIS

## A. PROGRAMME OF STUDY

1. The Department of Chemistry in collaboration with other faculty in Science offers a course-based programme in instrumental analysis leading to the degree of Master of Science. The programme is available on a full time or part time basis and will normally require four semesters of study. The programme is designed for students who wish to pursue career opportunities in all areas of applied science which require in-depth knowledge and laboratory expertise in analytical instrumentation.
2. The programme will be administered by a Programme Committee consisting of the Deputy Head (Graduate Studies) who will be chair, the Programme Coordinator (Chemistry) and a third faculty member from another science department. The Programme Committee will be responsible for overseeing that a level of standards be maintained.
3. The Programme Coordinator will be responsible for coordinating the course offerings and for soliciting student projects for the programme to be approved by the Programme Committee.

## QUALIFICATIONS FOR ADMISSION

Admission is limited and competitive. To be considered for admission, applicants shall normally hold a Bachelor's degree in Science (with at least a minor in Chemistry, and having completed Chemistry 4100 or equivalent) with at least a second class standing from an institution recognized by the Senate. The Programme Committee will make recommendations on admission to the Dean of Graduate Studies.

## PROGRAMME REQUIREMENTS

1. All programmes must be approved by the Programme Committee and by the Dean of Graduate Studies. All General Regulations of the School of Graduate Studies shall apply to this degree.
2. The programme requires the completion of the twenty-four credit hours representing the eight required programme courses, one project seminar, and a project report. Normally, completion of the programme will require four semesters of study.
3. A project seminar will be given to the Department of Chemistry at the end of the student's programme.
4. Students will be required to complete a research project, the scope of which will normally require no more than two semesters of full-time effort. The Project Report shall be evaluated according to the procedures outlined in General Regulations J.

82.5 Response to the Report of the Senate ad-hoc Committee on First Year Mathematics

A memorandum dated March 18, 1998 was received for information from the Head, Department of Mathematics and Statistics outlining the actions the Department of Mathematics and Statistics has taken, and may take in the future, to address recommendations $1,2,3,8$, $9,10,11$ and 12 contained in the report of the Senate ad hoc Committee on First Year Mathematics. Also included was a paper prepared by Dr. Sherry May titled "BRIDGING THE GAP: AN INDIVIDUALIZED MATHEMATICS REMEDIAL PROGRAMME FOR POSTSECONDARY BOUND INDIVIDUALS" which was prepared in response to Recommendation 2. of the Report of the ad hoc Committee.

Both Dr. Gaskill and Dr. May were in attendance at the meeting and responded to several questions from Senators.
82.6 Steering Committee for Strategic Planning

A memorandum dated 27 March, 1998 was received from the Senate Academic Planning Committee advising that the following terms of reference for a sub-committee, Steering Committee for Strategic Planning were approved at a meeting held on 26 March, 1998.
"In the spirit of Memorial University's ongoing endeavor to meet the challenges of the future as found in such documents as Launch Forth: A Strategic Plan for Memorial University of Newfoundland (1994), A Discussion Paper on University Transformation Principles, Strategies and Priorities (1997), and Budget Outlook 1997-98: Living Within Our Means (1997), the Senate Committee on Academic Planning, on 26 March, 1998, struck a Sub-Committee to act as a Steering Committee for Strategic Planning. The purpose of this Committee is

* to prepare a detailed strategic plan for Memorial University;
* to set out the basic educational and academic direction which should guide decision-making at Memorial;
* to indicate key initiatives and specific recommendations which the University should undertake in the years ahead in support of its mission, vision, and basic principles in such areas as teaching, research, enrolments, operating and capital budgets, administrative procedures, renewal of faculty and staff, and relations with the external community;
* to establish an interactive process with the University community;
* to review existing reports at Memorial, update factual material, hold public meetings, take written submissions, and invite contributions from students, committees of the University, the Senate, Board of Regents, administration, faculty, staff and the external community;
* to issue an interim report by January 1, 1999, for further discussion;
* to submit a final report to the SCAP by January 1, 2000, and then finally to Senate.

Membership of the Committee shall initially consist of

* two members from the Senate Academic Planning Committee
* two members from the Administration
* two members from the Faculty
* one graduate student
* one undergraduate student

The Committee shall elect its own chair."
This item was received for information.

### 82.7 Presidential Search Committee

A memorandum dated 26 March, 1998 was received from the Chair of the Board of Regents advising that Dr. May will retire as President and Vice-Chancellor at the end of his current term, on 31 August, 1999. A copy of the Resolution which was adopted by the Board of Regents at a meeting on March 12, 1998 authorizing the creation of a Presidential Search Committee was attached. The Resolution
states that the membership of the Committee shall consist of: the Chair of the Board, who shall chair the Committee... four members of the faculty, chosen by the Senate...

This document was discussed by the Executive Committee of Senate at a meeting held on March 26, 1998, when it was agreed that the Secretary, Dean Kealey, Dr. Rich, Dr. Schrank and Dr. Treslan, on behalf of the Executive Committee, would meet to formulate a recommendation for the consideration of Senate. A memorandum dated 1 April 1998 was received from the Secretary, Dean Kealey, Dr. Rich and Dr. Treslan (Dr. Schrank was unable to attend the meeting) recommending procedures for the selection of the four faculty representatives.

It was moved by Dean Kealey, seconded by Mr. Collins and carried that the following procedures be adopted:
A. That the four faculty representatives be elected from faculty and librarians following the Regulations for Senate Elections (copy attached).
B. In order to reflect as closely as possible the weighted composition of faculty and librarians, the following constituency groupings are approved:

Group 1 Business Administration, Education, Engineering and Applied Science, Marine Institute, Physical Education and Athletics

Group 2 Humanities, Music, Social Sciences, Library
Group 3 Medicine, Nursing, Pharmacy, Social Work, Sir Wilfred Grenfell College

Group 4. Science
Any faculty member or librarian who puts his or her name forward for appointment to the Committee be made aware of the strict confidentiality requirements as outlined in the letter dated 26 March, 1998 by the Chairman of the Board of Regents.

The election will be conducted under the aegis of the Senate Elections Committee.

In order to allow sufficient time for discussion of this item, it was moved by Dr. Adamec, seconded by Dr. Maxwell and carried that the Report of the Senate ad hoc Committee on Procedures Concerning the Removal of Academic Administrators be tabled until the May 12, 1998 meeting of Senate at which time it would be placed as the first item on the agenda for discussion at that meeting.
82.10 Search Committee for Vice-President (Academic)

These memoranda were received for information.
In response to questions from Senators with regard to the openness of the process of the search for a new Vice-President (Academic), the President requested that a memorandum which had been sent to Members of the Search Committee for Vice-President (Academic) on the topic of "Open" Versus "Closed" Candidate Evaluation be circulated to Senators for information.

### 82.11 Proposal for an Office of Ombudsperson

A memorandum dated March 23, 1998 was received from the Council of Students' Union and the Graduate Students' Union requesting an endorsement from Senate of a joint proposal for a University Ombudsperson.

Ms. Peckford, President, Graduate Students' Union presented the proposal and answered questions from Senators.

Following consideration, it was moved by Ms. Peckford, seconded by Dr. Adamec and carried, that the Senate support the proposal in principal and urge the Board of Regents to implement the establishment of such an office.

On behalf of Senate, the Chairman commended the two Student Councils on this initiative.

### 82.12 Information Session

Dr. Maynard Clouter was scheduled to present an Information Session entitled "The First Priority" following the meeting. However, because the number of items of pressing business which had to be considered, and in light of the lateness of the hour it was agreed to defer this session until the May 12, 1998 meeting of Senate. On behalf of Senate, the Chairman apologized to Dr. Clouter and thanked him for his attendance at this meeting. He suggested that in order to ensure that Dr. Clouter was given sufficient time for his presentation and to ensure the appropriate atmosphere for what he had to say, the session should be held prior to the start of the regular meeting. Dr. Clouter stated that he could make himself
available at that time, and it agreed that the Information Session be held prior to the regular meeting of Senate.

### 82.13 Item for Information

A copy of an advertisement attempting to recruit Newfoundland students to the University College of Cape Breton which was published in the March 21, 1998 edition of the Evening Telegram was circulated for the information of Senators.

The President spoke to Senators regarding the ever increasing competition for students, the large numbers of Newfoundland students who choose to attend other universities mainly in the Maritimes and the pressing need for Memorial to find ways in which to attract more students to this University. He noted that the Office of Student Recruitment and Promotion is working on some aspects of this problem, but suggested that in an effort to involve a greater cross-section of the University community the Senate should debate this issue at a future meeting.

Dr. Locke noted that while Senate should not be involved in developing a marketing strategy for the University, it should, for example, debate whether or not Memorial is still relevant to the broader society in which we live.

Dr. McKay commented on the potential impact that the recently announced College/University transfer programme between Memorial and the College of the North Atlantic might have on University enrollment.

It was moved by Dr. McKay, seconded by Dr. Adamec and carried that Senate undertake a serious discussion of these matters at the earliest opportunity.

It was further agreed that a meeting of Senate be held in June, 1998 to discuss these matters.

### 82.14 ADJOURNMENT
