78. MINUTES

The Minutes of the regular meeting held on March 11, 2003, were taken as read and confirmed.

79. Appeal of the Failing Grade Received in Education 401X

The above-noted student is appealing the decision of the Senate Committee on Undergraduate Studies with regard to the failing grade received in Education 401X, the internship component of the Bachelor of Education (Primary/Elementary) degree program taken in the 2002 Fall Semester. The student cites, as grounds for the appeal, lack of procedural fairness extended to him/her during the teaching internship. The student claims that had his/her evaluation been conducted fairly, and had the safeguards in the Internship Handbook been implemented, he/she could have rectified the problems identified. The student is of the belief that his/her internship should be upheld with full certification and seeks as a remedy that he/she be awarded a passing grade for the internship.

The student's appeal was originally considered and denied by the Faculty of Education Undergraduate Studies Committee. The student then appealed to the Senate Committee on Undergraduate Studies and at a meeting held on March 6, 2003, the Committee considered the appeal and found that the procedure used by the Faculty of Education was fair and agreed that the failing grade should stand.

Following a review of the documentation received, it was the decision of the Executive Committee to recommend to Senate that an ad hoc Committee be appointed to consider this case. In addition, and recognizing the student's desire to have this matter resolved quickly, the Committee is recommending that the ad hoc committee be asked to deal with this case as expeditiously as possible with a view to reporting to Senate by May 13, 2003 or at the latest by September 9, 2003.

It was moved by Mr. Collins, seconded by Ms. Bell and carried to accept the recommendation of the Executive Committee that an ad hoc Committee be appointed to consider this case and report back to Senate.

It was then moved by Dr. Gosine, seconded by Dr. Wolinetz on behalf of the Committee on Committees that the membership and terms of reference for the ad hoc committee to review the case be approved as follows (incorporating a friendly amendment made on the floor of Senate to the effect that the ad hoc Committee would interview the student):

Terms of Reference

The Senate ad hoc committee to consider an appeal of a failing grade in Education 401X in the 2002 Fall Semester:

- a. Will examine all documents submitted by the student in support of the appeal;
- b. May examine any other written evidence which it deems relevant;
- c. Will interview the student;
- d. May interview any individuals, organizations or institutions it deems relevant;
- e. May conduct further investigations as the committee deems necessary, and
- f. Will deal with this case as expeditiously as possible with a view to reporting to Senate by May 13, 2003 or at the latest by September 9, 2003.

Ad hoc Committee in Senate Reform

At a meeting of Senate held on March 11, 2003, Senate agreed to strike an ad-hoc committee to explore the possibility that some routine course approvals and regulation revisions be delegated, as appropriate, to committees reporting to Senate and/or be facilitated by electronic means, and to suggest the necessary changes in Senate's policies and procedures. It was also agreed that the mandate of the ad hoc committee include the composition of Senate with respect to the representation on Senate for students at the Marine Institute and certain department heads.

At a meeting held on March 21, 2003,the Committee on Committees drafted the Terms of Reference and membership for this ad hoc committee for approval by Senate. The motion to approve the terms of reference and membership was moved by Dr. Gosine and seconded by Dr. Gordon.

It was moved by Dr. Harris, seconded by Dr. McKay, and carried by a majority vote that the ad hoc committee membership be amended to include a representative from the Faculty of Medicine to reflect the unique nature of the Faculty's course and program delivery. The appointment will be recommended at the May 13, 2003 meeting of Senate.

A detailed discussion then followed surrounding the proposed Terms of Reference. Several Senators expressed the importance of widening the mandate of the committee to include consultation with all academic and faculty councils.

The motion to amend the Terms of Reference to include an additional clause which reads "To consult with academic and faculty councils and to consider the recommendations coming from these units" which was moved by Dr. McKay and seconded by Dr. Adamec, was carried by a majority vote.

The motion to amend clauses b), c) and d) in the Terms of Reference to add "and to consider the recommendations coming from these units", was carried by a majority vote.

The vote on the main motion as amended was taken and carried.

The amended membership and amended terms of reference for the ad hoc committee on Senate reform are as follows:

Preamble

The Committee shall examine questions raised in the memorandum of March 12, 2003 related to a request by the Deans and Directors concerning Senate Reform. Additionally, the Committee shall review the composition of Senate with respect to the representation on Senate for students at the Marine Institute and certain department heads. Background information related to these issues is attached.

Membership

- (a) Secretary of Senate
- (b) One undergraduate student to be recommended by MUNSU
- (c) One graduate student to be recommended by the GSU
- (d) A representative of the Deans and Directors
- (e) Seven (7) academic staff members, including 4 Senators, a representative from Sir Wilfred Grenfell College, a representative from the Marine Institute and a representative from the Faculty of Medicine
- Dr. Dennis Treslan (Education, Senator)
- Dr. Steve Wolinetz (Political Science, Senator)
- Dr. Glyn George (Engineering)
- Dr. Paul Wilson (SWGC, Senator)

Professor Vivienne Kuester (Human Kinetics and Recreation, Senator)

Mr. Brian Kerr (MI)

Representative from the Faculty of Medicine (recommendation to be made at the May 13, 2003 meeting of Senate)

Terms of Reference

Consistent with the composition, duties, and powers of the Senate and the duties and powers of the Board of Regents as defined by the Memorial University Act, the ad hoc Committee is charged with the following responsibilities:

- To consider procedures that will facilitate more efficient consideration of requests to Senate for routine course approvals and regulation revision approvals.
- To consult with Senate Committees and/or Academic Councils that regularly submit requests for course or regulation approvals to Senate and to consider the recommendations coming from these bodies.
- To consult with faculty and academic councils and to consider the recommendations coming from these councils.
- To consult with administrative units (e.g. Registrar's Office) that are involved in the implementation of decisions related to course or regulation changes and to consider the recommendations coming from these units.

- To consult with administrative units (e.g. Computing and Communications) that may be able to provide advice regarding appropriate technology that may be employed to improve the efficiency of considering routine approval requests and to consider the recommendations coming from these units.
- To consider whether changes in Senate composition should be recommended to the Board of Regents to provide for additional ex-officio Senate seats for the Heads of large departments in the Faculties of Arts and Science.
- To consider whether changes in Senate composition should be should be recommended to the Board of Regents to provide for a Senate seat for a student from the Marine Institute.
- To examine and make recommendations on any other matter deemed by the Ad-hoc Committee to be relevant to its principal task.
- To present a report on Senate Reform, including the presentation of alternative procedures for improving the efficiency of routine requests for Senate approval, to Senate at the October 2003 meeting.

Membership of Committee on Committees

At a meeting held on January 16, 2003, the Committee on Committees discussed the prospect of having the Secretary of Senate become an ex-officio member of the Committee. The Secretary of Senate has been attending meetings of the Committee for approximately 16 months at the invitation of the Committee. It is the consensus of the Committee that the Secretary of Senate brings an important perspective to the Committee as well as a very valuable resource through administrative support. The Committee is recommending that Senate change the terms of reference to include the Secretary of Senate as an ex-officio member of the Committee on Committees with regular voting privileges.

It was moved by Dr. Gosine, seconded by Dr. Wolinetz, and unanimously carried to change the Terms of Reference for the Committee on Committees to include the Secretary of Senate as an ex-officio member with regular voting privileges.
