Following the course description for 4600. Introduction to Research, insert the following:

"Prerequisite: Statistics 2550 (or equivalent) or permission of the instructor."

Page 314, 2001–2002 Calendar, amend Table 5 – Bachelor of Recreation (Co-operative) Programme, as follows:

"Year 2, Academic 3 – delete "Recreation 4600" and replace with "Statistics 2500" and Year 2, Academic 4 – delete "Statistics 2500" and replace with Recreation 4600".

42.2 Theatre Institute at Harlow

Page 112, 2001-2002 Calendar, under the heading Bachelor of Fine Arts (Theatre), immediately following the sub-heading Degree Regulations, amend the first paragraph to read as follows:

"To be awarded the Bachelor of Fine Arts (Theatre) a student shall successfully complete one hundred and twenty credit hours (thirty-six courses) which would...following pattern:"

Delete all references to the following:

Theatre Courses 4011, 4021, 4050, 4051, 4061, 4071, 4081, 4091"

Following the sub-heading Outline of Major Programmes, delete the first three paragraphs in their entirely and replace with the following:

"Students will major in one of two areas in Theatre Studies: acting or stagecraft/design. The major comprises seventy-five credit hours chosen in accordance with the following pattern: the introductory Theatre courses (1000, 1001, 1010, 1020) and the fourth-year Theatre courses (4030, 4040, and 4001 - Theatre Institute at Harlow) are common to both major options.

Students choosing Acting as a major will complete Theatre 1110, 2010, 2011, 2080, 2081, 3010, 3011, 3070, 3071, 3080, 3081, 4010, 4070, and 4090, in addition to the twenty-eight credit hours common to both majors.

Students choosing Stagecraft/Design as a major will complete Theatre 1120, 2020, 2021, 2090, 2091, 3020, 3021, 3060, 3061, 3090, 3091, 4020, 4060, and 4090, in addition to the twenty-eight credit hours common to both majors."

Page 114, 2001–2002 Calendar, under the sub-heading 4th Year, Winter, delete the listing in its entirety and replace with the following:

"Theatre 4001 (Theatre Institute at Harlow)"

Delete the following course listings in their entirety:

"4050. Selected Topics in Theatre History.

4051. Dramatic Theory and Criticism.

4010 and 4011. (Same as former 401A/B) Acting IV.

4020 and 4021. (Same as former 402A/B) Stagecraft IV.

4060 and 4061. Master Classes III and IV (Stagecraft).

4070 and 4071. Master Classes III and IV (Acting).

4080 and 4081. (Production-Acting)(4 cr. hrs. each).

4090 and 4091. (Production-Stagecraft)(4 cr. hrs. each)."

New courses:

"4001. Theatre Institute at Harlow (10 credit hours). A full semester's work, utilizing both the Harlow Campus and Sir Wilfred Grenfell College, comprising a "thesis production" involving fourth-year acting and stagecraft students in major responsibilities. A practical component in Theatre Criticism utilizing the resources of the Harlow Campus proximity to London and Stratford. A series of

Master Classes, Workshops, Field Trips and Guest Lectures offered by members of the theatre profession in England. A project in a selected area of theatre history.

Prerequisites: Theatre 4010 or 4011, 4060 or 4070, 4080 or 4090, 4030, 4040.

4010. (Same as former 401A) Acting IV. Advanced course for acting majors. Concentration on advanced scene study on texts illustrating period styles or genres of plays. This course will be directly related to performance work in Theatre 4080. Restricted to acting majors.

Studio: Six hours per week.

Prerequisites: Theatre 3010 and 3011, Theatre 3080 and 3081.

4020. (Same as former 402A) Stagecraft IV. Advanced course for stagecraft/design majors with individual concentration on specific technical and design skills. This course will be directly related to production assignments in Theatre 4080. Restricted to stagecraft majors.

Studio: Six hours per week.

Prerequisites: Theatre 3020 and 3021, Theatre 3090 and 3091.

4060. Master Class III (Stagecraft). Advanced work with a guest artist in a particular area of specialization. Restricted to Theatre majors.

Studio: Six hours per week.

Prerequisites: Theatre 3060 and 3061.

4070. Master Class III (Acting). Advanced work with a guest artist in a particular area of specialization. Restricted to Theatre majors.

Studio: Six hours per week.

Prerequisites: Theatre 3070 and 3071.

4080. (Production-Acting)(4 cr. hrs.). Work on a major production in a significant and leading capacity (i.e. leading or principal role). Restricted to Theatre majors.

Studio: Twenty hours per week.

Prerequisites: Theatre 3010 and 3011, Theatre 3080 and 3081.

4090. (Production-Stagecraft)(4 cr. hrs.). Work on a major production in a significant and leading capacity (i.e. designer, stage manager, technical director, etc.). Restricted to Theatre majors.

Studio: Twenty hours per week.

Prerequisites: Theatre 3020 and 3021, Theatre 3090 and 3091."

43. Report of the Academic Council of the School of Graduate Studies

43.1 School of Music

New program:

REGULATIONS GOVERNING THE DEGREE OF MASTER OF MUSIC

Professor and Director

The degree of Master of Music (M.Mus.) is offered by full-time study, normally commencing in the Fall semester. Three areas of specialization are offered: Conducting, Performance and Performance/pedagogy. Within these broad specializations there is considerable flexibility available to further focus the programme to meet specific interests and needs.

These programmes offer the musician the tools to make accelerated advances in comprehension, skills and abilities as a performing musician or conductor while offering at the same time, insights and experience into the métier of the musician/entrepreneur in the modern world. The School of Music has forged active partnerships with many of the professional music organizations and institutions

within the arts community in the greater St. John's region which afford an exceptional range of professional experiences to its graduate students. Included among these partners are the Newfoundland Symphony Orchestra, the Canadian Broadcasting Company, Heritage Canada, the Newfoundland and Labrador Arts Council and many others.

Graduate instruction is offered in instrumental and choral conducting, as well as in the following performance media: voice, piano, organ, flute, clarinet, saxophone, oboe, bassoon, trumpet, euphonium, trombone, tuba, percussion, violin, viola, cello and double bass.

A) QUALIFICATIONS FOR ADMISSION

- 1. Admission regulations and procedures are outlined in the General Regulations Governing the School of Graduate Studies and apply to the Master of Music degree. Candidates for admission will normally hold a B.Mus. degree with first-class standing from a recognized university. Applicants with other types of preparation should enquire with the School of Music regarding the likelihood of admission. The deadline for receipt of applications is January 31.
- 2. In addition to meeting the requirements in A.1. above, admission is further determined by audition and diagnostic examinations.
- a) Auditions for September entry will be held in February of each year on the St. John's campus. Where exceptional circumstances prevail and with the approval of the Director, the audition may be submitted as an audio or video recording. The audition will normally be the equivalent of a full-length solo recital (ca. 60 minutes performing time) in the performance medium. The programme should display a range of performance styles and repertoire. Prospective candidates should contact the School of Music for details on appropriate repertoire. Applicants to the M.Mus. in Conducting programme should submit professional quality video tapes of their work with a minimum of two different types of ensembles. These video tapes should include both rehearsals and performances. Performance tapes should display a range of styles and repertoire.

b) Candidates for admission will be required to write diagnostic examinations measuring their skills and knowledge in the standard areas of musical literacy. These include music theory and analysis, aural skills, and music history and literature which includes repertoire knowledge in the performance area. Candidates who display deficiencies in any of these areas may still be considered for admission. Once admitted, however, they will be required to take remedial course work in addition to the required programme requirements.

B. PROGRAMME OF STUDY

1. All candidates for the degree of Master of Music will be required to register for courses which combine course work, performance or work-study internships and which can normally be completed over two years by full-time study. Recital requirements as specified within each specific programme option are considered as thesis equivalents. Comprehensive examinations are not administered. The normal residency period in Conducting may, in some instances, be reduced through summer and intersession study or through a reduction of the credit requirements based on prior professional experience.

Candidates for the degree are required to complete the core courses in the first year of the programme. Principal and secondary applied course credits make up the largest concentration of programme requirements and are intended to be taken over two years. Courses in secondary concentrations and electives make up the balance of the programme.

- 2. All candidates for the M.Mus. degree must complete 36 credit hours which include MU 6001 and MU 6002.
- a.. All candidates in Conducting (Choral Conducting, Instrumental Conducting or Choral/Instrumental Conducting) must also complete the following courses: MU 6210, MU 6310, MU 6100; one of MU 6006, 6007 or 6008; and a total of six credits from among MU 6211, 7210, 6212, 6213, 6311, 7310, 6312 or 6313. Of the remaining twelve credit hours in electives, and with the approval of the Associate Director for Graduate Studies in the School of Music, three credit hours may be from related disciplines.

- b. All candidates in Performance (solo voice, instrument or chamber music) must also complete MU 645A/B, MU 745A/B; MU 6700, MU 6750; MU 6005 or 6009; and four credits from among MU 646A/B or 6500 or 6501. Of the remaining six credit hours in electives, and with the approval of the Associate Director for Graduate Studies in the School of Music, three credit hours may be from related disciplines.
- c. All candidates in Performance/Pedagogy (solo voice or instrument) must also complete MU 645A/B, MU 745A/B; MU 6600, MU 6650; E6959; and four credits from among MU 646A/B or 6500 or 6501. Of the remaining six credit hours in electives, and with the approval of the Associate Director for Graduate Studies in the School of Music, three credit hours may be from related disciplines.
- d. Further courses may be required depending on the background of the individual student.
- 3. Candidates with concentrations in Choral Conducting, Performance (voice) and Performance/Pedagogy (voice) will be required to demonstrate competence in two of French, German or Italian. Exit examinations in the chosen languages will measure understandings both of diction and translation. (See General Regulation G.2.d.)

ITEMS FOR INFORMATION

44. Centre for Advanced Computation and Visualization

A memorandum dated November 21, was received from the Vice-President (Academic) advising that at the November meeting of the Planning and Budget Committee, Dr. Mark Whitmore reported on a proposal to formally establish an Advanced Computation and Visualization Centre (ACVC)in the Faculty of Science. This Centre has been operational for some time and should now be officially opened.

Dr. Simpson noted that the recently approved Policies and Procedures for the Establishment of Institutes and Centres outlines the process by which centres of this type are to be created. However, the ACVC project was initiated well before the establishment of the new guidelines and should not be held to them, although their spirit was well exemplified in the actual process.

In his memorandum Dr. Simpson informed Senate that the Planning and Budget Committee agreed that ACVC should be recognized by the University.

A letter from Dr. Whitmore providing an overview of the project was included for the information of Senators.

This item was received for information.

45. Draft Memorial University Policy on Postdoctoral Fellows

A memorandum dated November 29, 2001 was received from the Acting Vice-President (Research and International Relations) submitting, for the information of Senate, a document entitled Policy on Postdoctoral Fellows which was developed by an ad hoc committee chaired by the Dean of Graduate Studies.

* On November 21, 2001, the Office of Alumni Affairs and Development hosted a function in Ottawa/Hull entitled

Newfoundland Affinity 2001 with a theme of Information Technology involving 180 participants. This event was the first of this kind to be held outside the province and proved to be very remarkable in terms of participation and speakers. Mr. John Kelly was the keynote speaker and Mr. Tom Bursey, an alumni living in the Ottawa region organized the event. Participants had an interesting time, learned many good things and networked. The President commented that this is the type of event that Memorial should do more of and he encouraged the submission of suggestions for similar types of events from other units.

* The Board of Regents has been asked by the provincial government to provide advice on the future of the university's name in light of the recent change in the official name of the province to Newfoundland and Labrador. The Minister of Youth Services and Post Secondary Education wrote to the Board of Regents advising that the names of all government institutions will be changed to include Newfoundland and Labrador in their titles, with the exception of Memorial University of Newfoundland and the Royal Newfoundland Constabulary. While Memorial is not a government institution, it is largely funded by the government, and the Minister asked the University to give consideration to changing the name of the University to reflect the name of the province. The Board considered this matter at a recent meeting and resolved that an Ad Hoc Committee be appointed to advise whether the name of the University should be changed. The Committee will consist of 13 members; comprising specifically, four students (one nominated by the President of MUNSU, one by the President of the GSU, one by the President of the Marine Institute Students' Union and one by the President of the Sir Wilfred Grenfell College Students' Union); a member of the University's faculty nominated by the President in consultation with the Chair of the Board; a member of the faculty nominated by MUNFA; a member of the staff nominated jointly by the other Unions certified to represent employees of the University; an alumnus or alumnae nominated by the President of the Memorial University of Newfoundland Alumni Association: the President: and four Regents (with one of them being designated as the Chair) nominated by the Chair of the Board (after consideration of any names suggested by his colleagues). The Committee will also be requested to seek suggestions as to whether the name should be changed, and if so to what, from all members of the University Community and from the public at large, including in particular the

Royal Canadian Legion. The Committee will be required to submit its report by 15 March 2002.
