## 109. APPEAL TO SENATE

ECS 2006-07: #4 - Following the normal appeals process, this student's appeal to be awarded the degree of Master of Science was denied by Senate in September 2000. This request was made on the basis of courses successfully completed, research carried out and a co-authored publication in which the appellant is cited as the third of four authors arising from research done while registered in a Master's program at Memorial University from September 1971 to August 1974. In September 2005, the student submitted additional material and requested that his/her appeal be reconsidered. The Academic Council of the School of Graduate Studies and the Executive Committee of Senate each reconsidered the case and concluded that the new material did not warrant further consideration of the appeal.

Following discussion, it was moved by Dr. Sharpe, seconded by Professor Riser that the appeal be denied. The motion carried by a majority vote.

At this point, Dr. Meisen joined the meeting and assumed the Chair.

# 110. REPORT OF THE SENATE COMMITTEE ON UNDERGRADUATE STUDIES

# 110.1 <u>Bachelor of Resource Management Degree Program at Sir Wilfred Grenfell</u> <u>College</u>

Professor Walsh presented the proposed Bachelor of Resource Management Degree Program to be offered at Sir Wilfred Grenfell College following which Dr. Ashton provided a history of the development of the program. Dr. Ashton noted that the idea of offering the proposed Bachelor of Resource Management Degree program arose out of a review of the forestry program. For several years, Sir Wilfred Grenfell College offered the first two years of a forestry degree program in collaboration with the University of New Brunswick. However, enrolments in the program declined and as a result, the program was not sustainable and was suspended. Dr. Ashton also noted that in several locations across Canada, forestry programs have been suspended and resource management programs have been developed.

Dr. Ashton remarked that the proposed program will complement and enhance the St. John's campus offerings and provide students with a program in an emerging area of importance. The program will enhance the Environmental Science and Environmental Studies programs currently offered at the College. The program also links well with government's intention for a research and development strategy plus it will benefit from the

newly established Canada Research Chair in Ecological Economics. Dr. Ashton noted that officials at Sir Wilfred Grenfell College will be working to develop an articulation agreement with the College of the North Atlantic in order to allow graduates of appropriate diploma programs to receive advanced standing within the Sustainable Resource Management program.

Following a brief discussion, the motion to approve the proposed Bachelor of Resource Management Degree Program at Sir Wilfred Grenfell College which was moved by Professor Walsh and seconded by Dr. Ashton, carried by a majority vote.

Page 399, 2007-2008 Calendar, insert the following section preceding <u>8.6</u> Minor Programs - Division of Science:

"Bachelor of Resource Management

Regulations for the General Degree of Bachelor of Resource Management

The program consists of a Sustainable Resource Management core which provides an interdisciplinary understanding of management activities within the context of the physical, social and economic environments.

The program requires a total of 120 credit hours as follows:

- A. The interdisciplinary Major in Sustainable Resource Management consisting of 84 credit hours.
  - 1. Biology 1001, 1002, 2600

  - 8. Two of Environmental Science 2371, Environmental Science 2369, Biology 2010, Biology 2122, Biology 2210
  - 9. Statistics 2500
  - 10. One of Environmental Science 3072, 3110, 3130, 3131, 4132, Earth Science 3811
- B. 6 credit hours in first-year English
- C. 30 credit hours in elective courses. When selecting electives, students are reminded that the **Core Program Requirements** for a Sir Wilfred Grenfell College degree program must be met."

Renumber section <u>8.6 Minor Programs - Division of Social Science</u> as <u>8.7 Minor Programs - Division of Social Science</u>, <u>8.7 Articulation Agreement with the College of the North Atlantic as 8.8 Articulation Agreement with the College of the North Atlantic, and <u>8.7.1 For Graduates of the Two-Year Adventure Tourism Diploma Program</u> as <u>8.8.1 For Graduates of the Two-Year Adventure Tourism Diploma Program</u>.</u>

Page 421, 2007-2008 Calendar, under the heading 11.14 Forestry, add the following new courses:

"3000 Sustainable Forestry addresses current methods and technologies for the implementation of sustainable forestry practices. The theoretical, practical, and actual ranges of choice for sustainable forestry practice are explored from a global perspective.

Credit Restrictions: None.

Prerequisites: SRM 2000, SRM 2001, and BIOL 2600.

Lectures: 3 hours per week.

**3200 Forest Management and Policy** addresses the fundamentals of forestry management including policies and legislation at provincial, national, and international levels.

Credit Restrictions: None.

Prerequisites: SRM 2000, SRM 2001, FORS 3000, and BIOL 2600.

Lectures: 3 hours per week."

Following 11.28 Sociology, add a new section "11.29 Sustainable Resource Management" and add the following new courses, renumbering 11.29 to 11.33 accordingly:

**"2000 Sustainable Resource Management I: Marine and Terrestrial Environments** is an introduction to the interdisciplinary field of sustainable resource management, including marine and terrestrial environments. The course focuses on sustainable practices rather than profit or resource extraction optimization. First Nations' perspectives will also be considered. Credit Restrictions: None.

Prerequisites: GEOG 1000 or GEOG 1050.

Lectures: 3 hours per week.

**2001** Sustainable Resource Management II: Industry-Specific Approaches develops the topics presented in SRM 2000 with reference to specific industries such as the fishery, forests, mining, oil and gas, soils, and water. This course traces the importance of resources in their historical context both locally and globally.

Credit Restrictions: None. Prerequisite: SRM 2000. Lectures: 3 hours per week.

**3000 Regional Planning and Management** is an introduction to the concepts and processes of regional planning, development, and management. The course addresses planning history and dominant historical contributions to regional, urban, and rural morphology. Planning theory, planning practice, and management strategies are studied.

Credit Restrictions: None.

Prerequisites: SRM 2000, SRM 2001.

Lectures: 3 hours per week.

**3001 Environmental Planning and Management** focuses on balancing economic growth and environmental objectives. Environmental risk analysis, environmental auditing, and First Nations' perspectives will also be studied.

Credit Restrictions: None. Prerequisite: SRM 3000. Lectures: 3 hours per week.

**3002 Biodiversity** focuses on the three dimensions of biodiversity (genetic diversity, species diversity, and ecosytem diversity) and their relationships. Biodiversity will be addressed from an interdisciplinary perspective as genes, species, and ecosystems are of economic and biological interest.

Credit Restrictions: None.

Prerequisites: BIOL 1001, SRM 2000, SRM 2001.

Lectures: 3 hours per week.

**4000 Remote Sensing, Image Interpretation, and Resource Management** builds on topics introduced in EVST 2000 and EVST 3001. The course addresses the use of remotely-sensed images to track the location, health, and variety of natural resources such as forests, crops, and migratory populations. The lab component of the course employs GIS, GPS, satellite imagery, and aerial photography to address research concerns such as oil spills, forest fire management, iceberg tracking, ocean temperature monitoring, mining exploration, and oil and gas development.

Credit Restrictions: None.

Prerequisites: EVST 2000 and EVST 3001.

Lectures: 3 hours per week. Laboratory: 3 hours per week.

**4001 Renewable and Non-Renewable Energy Resources** presents an interdisciplinary approach to renewable and non-renewable energy resources and their management. The course examines the existing industrial economy's dependence on fossil fuels and studies renewable energy resources such as wind, solar, and geothermal.

Credit Restrictions: None. Prerequisite: SRM 2000. Lectures: 3 hours per week.

**4002 Risk Assessment and Management** is an introduction to risk assessment and management as interdisciplinary processes.

Credit Restrictions: None. Prerequisite: EVST 4000. Lectures: 3 hours per week.

**4003 Environmental Law** is an introduction to laws protecting the environment in Canada and elsewhere. The course examines environmental rules and activities through the study of legal precedents and contexts. Laws and policies of the federal, provincial, and local levels of government (including those pertaining to First Nations) are addressed insofar as they affect the environment. Case studies are employed.

Credit Restrictions: None.

Prerequisites: EVST 1000 and SRM 2000.

Lectures: 3 hours per week.

**4010 Research Seminar in Sustainable Resource Management** is the senior seminar in which selected sustainable resource management topics are examined from an interdisciplinary perspective. The seminars are presented on current research and environmental issues by faculty, students, and guest speakers from universities, government, and industry.

Credit Restrictions: None.

Prerequisite: Enrolment in the final year of the SRM program or permission

of the program Chair.

Lectures: 3 hours per week.

**4901-10 Special Topics in Sustainable Resource Management** will have topics to be studied announced.

Credit Restrictions: None.

Prerequisites: SRM 2000 and SRM 2001.

Lectures: 3 hours per week.

**4950 Independent Research Project** requires that students carry out an approved project on a topic in Sustainable Resource Management and prepare a major paper under the supervision of a faculty member. Students will undertake both a systematic literature review and independent research.

Credit Restrictions: None.

Prerequisite: Permission of the SRM Chair."

Page 382, 2007-2008 Calendar, in the Table of Contents, under section 8 Division of Social Science, add "8.6 Bachelor of Resource Management" and renumber items 8.6, 8.7, 8.7.1 as 8.7, 8.8, and 8.8.1.

In the Table of Contents, under section <u>11 Course Descriptions</u>, add "11.29 Sustainable Resource Management" and renumber items 11.29 - 11.33 accordingly.

Page 389, 2007-2008 Calendar, under the heading <u>4 Sir Wilfred Grenfell</u> College Core Program Requirements, revise first sentence to read as follows:

"Students completing the Bachelor of Arts, Bachelor of Business Administration, Bachelor of Resource Management and Bachelor of Science degree programs at Sir Wilfred Grenfell College must complete Core program requirements as follows:"

In item 3 Breadth of Knowledge Requirement, amend Group B to read as follows:

# 112. <u>STANDARDS OF BEHAVIOUR IN MEMORIAL UNIVERSITY LIBRARIES</u>

A memo dated 17, 2007 was received from the University Librarian recommending that a policy entitled "Standards of Behaviour in Memorial University Libraries" be developed. In introducing the policy, Mr. Ellis noted the need for such a policy following dealings with a library user whose behaviour became problematic. The policy outlines the Library's expectations of user behaviour.

The motion, which was moved by Mr. Ellis and seconded by Dr. Adamec, that the proposed Policy on Standards of Behaviour in Memorial University Libraries (incorporating a friendly amendment made on the floor of Senate to Clause V. "Suspension of Privileges" that the decision of the Senate Advisory Committee on the Library could be appealed to Senate), be forwarded to the Board of Regents for consideration, carried.

# 115. <u>MEMORIAL UNIVERSITY OF NEWFOUNDLAND STUDENT'S UNION REPRESENTATION ON THE SENATE COMMITTEE ON COMMITTEES</u>

# 116. REQUEST FROM THE MEMORIAL UNIVERSITY OF NEWFOUNDLAND STUDENTS' UNION TO AMEND THE SENATE BY-LAWS AND PROCEDURES

A request was received from the Memorial University of Newfoundland Students' Union recommending amendments to Section II.D. "Selection of Student Members", II.E. "Term of Office for Student Members", VI. "Senate Committee Procedures" and VII. "Standing Committees" of the Senate By-Laws and Procedures. Following consideration, it was moved by Ms. Power, seconded by Dr. Campbell and carried that the following amendments be approved for submission to the Board of Regents (NOTE: The highlighted text indicates new text and the underlined text indicates current text that is to be eliminated):

#### "II. MEMBERSHIP OF SENATE and ELECTIONS TO SENATE

- D. Selection of Student Members
  - 1. The Graduate Students' Union shall select three representatives, each representing a different academic area. The selection procedures shall be determined by the Graduate Students' Union.
  - 2. Ten Senators shall be selected by the undergraduate students, each representing a different academic area. The ten undergraduate student senators shall consist of seven student senators from the St. John's campus, two student senators from the Sir Wilfred Grenfell College at Corner Brook and one student senator from the Marine Institute. The procedure controlling such selection shall be determined by the respective Students' Union.
  - 3. To be eligible for selection to the Senate, an undergraduate student shall have obtained a minimum of sixty credit hours and be in clear standing except in the case of the Sir Wilfred Grenfell College at Corner Brook where a minimum of thirty credit hours must be obtained and in the case of the Marine Institute where a student shall have obtained fifteen semester credits, be in clear standing as defined by the Institute's academic regulations and be enrolled in a programme offered through the Institute.
  - 3. To be eligible for selection to the Senate, an undergraduate student shall be in clear standing and be enrolled in a program offered through the campus of Memorial University, which the student represents in accordance with D.2 above.
  - 4. The Students' Unions will strive for a balance of student senators representative of the student body.

# Request from the Memorial University of Newfoundland Students' Union to Amend the Senate By-laws and Procedures (cont'd)

- E. Term of Office for Student Members
  - 1. The term of office for student representatives shall run from April 1 to March 31.
  - 1. The term of office for student representatives shall run from May 1 to April 30."

Senate also approved the related proposal from MUNSU that Section VI.A.6 "Senate Committee Procedures" be amended so that the term of office for student representatives on Senate Committees shall be from May 1 to April 30 as well as Section VII.J. and L. "Standing Committees" in order to reflect the change in titles for members of the revised executive structure of MUNSU as follows:

#### "VI. SENATE COMMITTEE PROCEDURES

- <u>6. The term of office of student representatives on Senate Committees shall be from April 1 to March 31.</u>
- 6. The term of office of student representatives on Senate Committees shall be from May 1 to April 30."

# 118. <u>REMARKS FROM THE CHAIR - QUESTIONS/COMMENTS FROM SENATORS</u>

- Dr. Meisen announced that Dr. Geoffrey Rayner-Canham, Sir Wilfred Grenfell College, was named as one of the 2007 3M Teaching Fellows.
- During the period April 9 to 11, 2007, Dr. Meisen travelled to the United Kingdom. While there, he attended the Harlow Board of Trustees meetings, the Board of Directors of MUN (UK) meetings and held meetings with donors. Dr. Meisen also visited Ireland and chaired a session at the *National Coastal Conference* to help build partnerships between marine experts in Europe and Memorial University.
- On April 17, 2007, the President was in Saskatoon attending a meeting of the Association of Universities and Colleges where a presentation entitled "*Trends*" was given. Dr. Meisen encouraged Senators to read the document which highlights national enrolment trends.
- On April 24, 2007, Dr. Meisen hosted John Lau, President and CEO of Husky Energy Inc., with regards to the \$500,000 Husky Endowment Fund increase.
- On April 26, 2007, Dr. Meisen attended the 2007-08 Provincial Budget Speech. In providing an overview of the budget, he noted the following highlights relating to post-secondary education:
  - there will continue to be a freeze on tuition fees. As well, government has lowered the interest rate on provincial student loans.
  - operating funds have increased by almost \$14M. Funding has also been provided in a number of important areas which includes the creation of two new residences (one at the St. John's campus and one at the Sir Wilfred Grenfell College campus), the construction of a new academic building in Corner Brook and the School of Ocean Technology at the Marine Institute.
- On May 6, 2007, the President hosted a luncheon with new faculty and their families. He extended a warm thank you to the students from the Faculty of Education as well as to Ms. Karen Hollett and the staff of the Office of Faculty Relations who organized the luncheon.
- On May 7, 2007, Dr. Meisen hosted the open meeting of the Katz Action Groups.

On the same date, he attended the "Rant Like Rick" awards ceremony.

#### 119. ANY OTHER BUSINESS

### 119.1 Sir Wilfred Grenfell College Review - Davies/Kelly Report

Dr. Meisen reported that on April 27, 2007, the Provincial Government released the Davies/Kelly report. The report recommends that there be two universities in the Memorial University system: a Memorial University (St. John's) and a Memorial University (Corner Brook) each with its own president, budget and Senate. However, the report recommends that both universities would be part of the overall Memorial University system and would share the same Board of Regents. Dr. Meisen noted that this far reaching report is before Senate today for information and for discussion of process at this stage. He recommended that at a future meeting, Senate should engage in discussion on this important topic which has a bearing on the academic life of the University as well as Senate itself.

Dr. Campbell then reiterated that the report has many implications for academic life at Memorial University and he suggested that Senate must consider these implications. He recommended that an ad hoc committee be established to consider the implications and areas of strategic academic importance arising from the report. In this regard, it was moved by Dr. Adamec and seconded by Dr. Lucas that Senate request the Committee on Committees to act as quickly as possible to recommend membership for an ad hoc committee with the mandate and membership structure as follows:

#### "Mandate

To identify and comment on major implications and areas of strategic academic importance arising from the Davies/Kelly report on the Sir Wilfred Grenfell College Review and to prepare a report for Senate in time for a meeting of Senate to be held on June 12, 2007.

#### Membership Structure

- A. One academic staff member from each of the St. John's campus, Sir Wilfred Grenfell College and the Marine Institute.
- B. Two student representatives: one to be nominated by the Memorial University of Newfoundland Students' Union and the other to be nominated by the Grenfell College Students' Union.
- C. One academic administrator from Sir Wilfred Grenfell College and one from the St. John's campus.
- D. Secretary.

The Committee may decide to elect a chair or co-chairs."

Dr. Ashton then spoke noting that Memorial University and Sir Wilfred Grenfell College have been grappling with issues around the status of the College and the relationship of the College within Memorial University for the past 15 years. In late 2005, the provincial government chose to exercise its responsibility in developing a strategic policy framework for higher education in the province and undertook to bring final resolution to the issue

when it established a Commission to "conduct a review of the various degrees of autonomy for Sir Wilfred Grenfell College up to and including full university status, and report their findings to government so that it can make an informed decision on the future of the College with the aim of increasing Grenfell's autonomy". Officials from the College participated fully in that exercise as did officials from the rest of the University. Dr. Ashton reminded Senators that Government has announced the creation of a committee that will be established in the coming weeks to determine how best to implement the new governance structure and to explore all aspects associated with the change. In addition to working closely with the Board of Regents, the committee will have representation from student union representatives, senior executive members of both Memorial University and Sir Wilfred Grenfell College and the Department of Education.

Dr. Ashton noted that while College officials are fully cognizant of the implications, they also recognize that not all members of Senate have been engaged in these debates and may not be as knowledgeable in this matter. Dr. Ashton then noted that for this reason the College would participate in an ad hoc committee of Senate to examine implications with a view to implementing the proposed changes. However, they would withdraw their representatives from the process if they feel they are being put in a position which is questioning government's decision.

Following a brief question and answer period, the vote on the main motion that Senate request the Committee on Committees to act as quickly as possible to recommend membership for an ad hoc committee with the mandate and membership structure noted above carried by a majority vote.

The Secretary then asked Senators to consider volunteering or nominating others to serve on this important ad hoc Committee.

The President advised Senators that the date of the next meeting of Senate is tentatively scheduled for June 12, 2007.
