24. Report of the Committee on Senate Elections

Ms. Sheila Singleton, Chair of the Committee on Senate Elections, advised Senate that in view of the significant challenges faced in recruiting faculty members to serve on Senate Committees, the Committee is planning to

discuss the definition of faculty members with regards to eligibility for serving on Senate Committees. In particular, the Committee plans to examine a more liberal definition with the possibility of including those contractual faculty members who are beyond their first year as well as retired members of the faculty. The Committee would then bring a revised proposal to Senate for debate. Ms. Singleton asked that Senators who have suggestions or thoughts on this topic, forward them to her for review by the Committee.

Following a suggestion from Dr. McKay, it was agreed to place this matter on the agenda for the next meeting of Senate for further debate before the Senate Elections Committee formulates a position on the matter.
25. Annual Report of the Senate Committee on Course Evaluation

The Annual Report of the Senate Committee on Course Evaluation, 20092010 Academic Year, was received for the information of Senate. Professor Matthew Janes, Chair, Senate Committee on Course Evaluations, was present and responded to questions from the floor.

## 26. Appointment of Chair, CEQ Review Committee

A memorandum dated 27 October 2010 was received from Matthew Janes, Chair, Senate Committee on Course Evaluations, regarding the Appointment of Chair of the CEQ Review Committee.

In May, Senate approved a proposal to create a committee to review the CEQ and its associated processes. At that time, Senate also approved a committee composition that reflected a balance of stakeholders from across the university. The Senate Committee on Course Evaluation (SCCE) recently sent out two calls for statements of interest to the university community regarding the Chair and Faculty Member positions on the CEQ Review Committee. Professor Shane O'Dea was the single nomination received for the position of Chair, and at a meeting on 25 October 2010, his nomnation was moved and unanimously carried by the SCCE.

While Senate has empowered the SCCE to select the members of the CEQ Review Committee, in the absence of a clear rule regarding eligibility for faculty members to serve on subcommittees, the SCCE is requesting that Senate approve the appointment of Professor Shane O'Dea as Chair of the CEQ Review Committee.

While Professor O'Dea is a recently retired faculty member who was just named as Professor Emeritus, the SCCE understands that this does not preclude his involvement in a subcommittee of a Senate Standing Committee. Indeed, it is understood that Senate policy permits retired faculty members to continue their appointed terms into retirement and that the Board of Regents has created a new employment category for retired faculty and staff who are involved in university projects.

It was moved by Mr. Collins, seconded by Dr. Simpson, and carried that Senate approve this appointment on a one time only basis which would not be precedent setting.

Professor Janes also noted that the Committee is still finalizing the membership and may add a new member to that committee for balance.

28. REMARKS FROM THE CHAIR - QUESTIONS/COMMENTS FROM SENATORS

In response to Dr. Wilson's request at the September 14, 2010 meeting of Senate for any update on the Joint Government/University Committee on University Autonomy, Dr. Kachanoski report that he has sent a letter to the Minister of Education indicating that the University representatives have been confirmed and are prepared to meet. The University is now awaiting a response from the Minister.

Dr. Kachanoski reported on his activities over the last two months with emphasis on activities relating to his installation as President, fall convocations, the Presidential Task Force on Aboriginal Students, the searches for the two Vice-Presidents, Task Force on a Renewed Governance Structure for Grenfell Campus, meet and greets with faculty, budget briefings, meetings with the Deputy Minister regarding budget presentation, AUCC meetings with University Presidents, Consolidation of Nursing Education, and the Strategic Plan.

Dr. Kachanoski noted that he has received a very warm welcome to Memorial and while the past two months have been very busy, he has enjoyed the experience immensely.

## 29. OTHER BUSINESS

### 29.1 Search Committee for the Associate Vice-President (Research)

A memorandum dated November 1, 2010, has been received from Christopher Loomis, Vice-President (Research), regarding the Search Committee for the Associate Vice-President (Research).

In accordance with the Policies and Procedures Governing the Appointment, Review, Promotion and Tenure of Academic Administrators, Dr. Loomis is establishing a committee to conduct a search for the position of Associate Vice-President (Research) whose appointment will be effective January 1, 2011.

## Search Committee for the Associate Vice-President (Research) (cont'd)

The search committee will consist of six members:

- two appointed academic staff members
- three elected academic staff members
- and Dr. Christopher Loomis as Chair

In the case of the three elected academic staffmembers, Dr. Loomis proposed that the elections take place following the Regulations for Senate Elections. In order to reflect as closely as possible the weighted composition of faculty and librarians, the following constituency groupings are proposed:

| GROUP | CONSTITUENCY |

| 1 | Humanities and Social Sciences |
| 2 | Medicine, Nursing, Pharmacy, Social Work |
| 3 | Science |
| 4 | Business Administration, Engineering and Applied <br> Science, Library and Grenfell Campus |
| 5 | Education, Marine Institute, Music, Human Kinetics and <br> Recreation, and the Counselling Centre |

Dr. Loomis noted that assuming endorsement by Senate, he will ask the Committee on Senate Elections to begin the nomination and election process immediately and to inform his office in writing of the results as soon as possible. Faculty members comprising the odd numbered constituency groups above (i.e. groups 1, 3 and 5) will be invited to participate by an election process to determine a representative for the Committee. In order to provide a balanced representation, he will then choose one representative from each of the even numbered groups above (i.e. groups 2 and 4).

Student Senators noted the absence of students on this committee and Dr. Loomis indicated that he will take the matter under advisement.

Following a lengthy discussion regarding the composition of search committees for Vice-President positions, which are seen as requiring broad representation reflecting the wide ranging portfolio versus Associate VicePresident positions which can sometimes be operational and narrow in scope, it was agreed that this topic would benefit from further discussion at a future meeting of Senate.

[^0]:    Section VII. Appointment and Review of Vice-Presidents, Associate VicePresidents and the Principal of the College.
    The procedures to be used in the search for, appointment of, and review of Associate Vice-Presidents, Vice-Presidents and the Principal of the College shall be initiated by the President and shall be broadly consistent with those specified for the appointment and review of Deans, Directors, and the University Librarian, except that, in the case of appointment, the names of the candidates may be kept confidential.
