A memorandum dated October 24, 2013, was received from the Senate Committee on Elections and Committees advising that part of the terms of reference, noted in Senate By-Laws and Procedures, VII., H.2.(d), of the Senate Committee on Elections and Committees (SCEC) is to "recommend for Senate approval the structure and terms of reference of Senate standing committees."  - (k) An appropriate number of academic staff members
- 3. Terms of Reference
 - (a) To propose minimum standards for the acceptance of undergraduate students into the University, their continuance in their programs and their readmission;
 - (b) To propose amendments to general University Regulations pertaining to undergraduate studies.
 - (c) To examine any proposed amendments to existing University Regulations on Undergraduate Studies and any proposed new regulations on Undergraduate Studies which originate elsewhere in the University before submission to Senate.
 - (d) To examine proposals for all new undergraduate programs and all extensions and changes in existing programs before submission to Senate. The Committee will require units submitting such proposals to indicate in writing that sufficient material and non-material resources are available to operate

the proposal and the ways, if any, that existing programs may be affected. In the event that the Committee is not satisfied, it may request further information or refer the matter to the Office of the Provost and Vice-President (Academic) or the appropriate Vice-President for further consideration.

- (e) To approve on behalf of Senate, all new undergraduate courses and changes in existing courses. On a regular basis, Senate will be informed of the courses so approved, the courses being listed by Department, course number and title.
- (f) To advise Senate and the Provost and Vice-President (Academic) on all matters pertaining to Undergraduate Studies.
- (g) To present a monthly report on Undergraduate Studies to Senate.
- (h) To act on matters delegated to it by Senate, in particular appeals and requests for waivers of regulations in accordance with procedures, policies and regulations approved by Senate.
- (i) The Committee shall confirm that consultation regarding calendar changes has been undertaken with the St. John's Campus, the Grenfell Campus and the Marine Institute.
- (j) To monitor grades, to flag grades considered to be anomalous, and to request from academic units, explanations for anomalies."

REGULAR AGENDA

31. <u>REPORT OF THE SENATE COMMITTEE ON UNDERGRADUATE</u> <u>STUDIES</u>

31.1 Firearms on Campus

Mr. Riggs noted that Campus Enforcement received a memorandum, dated July 26, 2013, from the Royal Newfoundland Constabulary which noted that there may be concerns related to members of the Royal Newfoundland Constabulary wearing their service firearm, when in uniform, while attending class at Memorial University.

A memorandum dated 30 September 2013 was received from Jennifer Porter, Deputy Registrar (Acting) and Secretary to the Senate Committee on Undergraduate Studies, noting that at a meeting held on 26 September 2013, the Committee considered a proposal from Campus Enforcement and Patrol that Subsection 8.4 Firearms on Campus of Section 8 Student Affairs and Services which is currently under the General Information section of the University Calendar be revised. Following consideration, it was the decision of the Committee that this particular regulation would be more appropriately placed in the University Calendar under Section 6 Non-Academic Regulations as Subsection 6.2 Firearms on Campus. Therefore, the following calendar change has been approved for submission to Senate:

"6.2 Firearms on Campus

Memorial University prohibits the possession, storage, or use of firearms, ammunition, or weapons on any property of the University without written permission of the Manager of Campus Enforcement and Patrol. Police officers enrolled in a course who may need to attend classes while on active duty in uniform shall, at the start of classes for each semester/session, present to the course instructor a copy of their written permission."

It was moved by Mr. Riggs and seconded by Dr. Tulett to approve this calendar change.

Firearms on Campus (cont'd)

Mr. Riggs then introduced Sergeant Bill James from the Royal Newfoundland Constabulary who gave a presentation on the safe handling of firearms and answered questions from the floor.

There was discussion/concern around whether the officers need to be on duty while attending classes, if students/instructors are comfortable around firearms as this could affect class structure and dynamics, flexibility in shift assignments, and if the officers should sit in a specific place in classrooms.

Sergeant James stated that it is a requirement for officers to wear the uniform when on duty, and a firearm is a mandatory part of the uniform. Officers have been going to Memorial University for the past nine years and it is encouraged that they upgrade for promotions.

The motion was put to a vote and carried.

Mr. Riggs noted that during its review of this proposal, the Senate Committee on Undergraduate Studies also agreed to recommend to Senate that the University consider developing a formal weapons policy which would include an authorization process to Campus Enforcement and Patrol, the definition of weapon, any exemptions, etc.

It was moved by Mr. Riggs, seconded by Dr. Mulligan, and carried that Senate recommend the establishment of a university group to propose a formal weapon policy and agreed there would be communication with the Chief of the Royal Newfoundland Constabulary regarding flexible scheduling for Officers.
