## 98. <u>Report of the Committee on Undergraduate Scholarships, Bursaries and Awards</u>

On page 47 of the 2022-2023 University Calendar under section <u>8.2 Scholarship</u> <u>Standing</u> amend as follows:

- "1. Scholarship standing for undergraduate entrance students (who are Canadian citizens or permanent residents graduating from secondary schools within Canada) is defined as a 75% average compiled from the final grades received in secondary school courses required for University admission. In the case of a tie for a competitive recognition that is based solely on academic merit, grades in additional secondary school courses may be considered in determining the recipient.
- 2. Scholarship standing for undergraduate students is defined as a 75% average over the previous scholarship year and the successful completion of not less than 30 credit hours, or equivalent load hours as recorded in the University's Student Information System, over that period. In considering students who complete more than 30 credit hours for which numeric grades are awarded, the average on the best 30 credit hours completed will be reviewed. Students who fail one or more courses during the scholarship year, regardless of the number of courses completed, will not be eligible for scholarships.
- 3. For scholarships that include financial need as a criterion and for bursaries that include scholarship standing as a criterion, scholarship standing for undergraduate students is defined as a 75% average over the previous scholarship year and the successful completion of not less than 24 credit hours over that period. In considering students who complete more than 24 credit hours for which numeric grades are awarded, the average on the best 24 credit hours completed will be reviewed. Students who failed one or more courses during the previous scholarship year, regardless of the number of courses completed, will not be eligible for scholarships.
- 4. First-class standing for scholarships purposes is defined as a grade point average of 3.5 out of 4.0 over the previous scholarship year
- 5. Students transferring to Memorial University of Newfoundland from Universities/Colleges in Canada which are members of Universities Canada and who meet scholarship standing as defined by Memorial University of Newfoundland will be eligible for undergraduate scholarships in the year in which they transfer. Such students must notify the Scholarships, Awards, and Financial Aid Office in writing of their intention to transfer and provide a complete transcript for the year in question.
- 6. Not all students who meet the above definitions of scholarship standing will receive a scholarship.

# **REGULAR AGENDA**

#### 100. <u>Report of the Teaching and Learning Committee</u>

Senate received and reviewed the background information for the Teaching and Learning Committee's report of the Categories of Experiential Learning. It was reported that three categories of experiential learning, work-integrated learning (WIL), community-engaged learning (CEL) and curriculum-integrated experiential learning (CIEL) will be noted on a student's transcript. It will help identify to students and communicate to those who review graduates' transcripts the for-credit learning experiences where students engaged in experiential learning, over the course of their studies at the University.

It was motioned by Dr. Myrick and seconded Dr. Bezzina to approve the Report of the Teaching and Learning Committee as presented. Motion Carried.

#### 101. Report of the Honorary Degrees and Ceremonial Committee

Senate received and reviewed the Report of the Honorary Degrees and Ceremonial Committee regarding the Provincial Anthem, "Ode to Newfoundland

At a meeting held on December 13, 2022, Senate received and considered a motion regarding the suspension of the current version of the Ode to Newfoundland during Convocation ceremonies. The motion supported this suspension and recommended to consult with the Government of Newfoundland and Labrador to urge that the composition's wording be updated and adapted. Recognizing the complex issues surrounding this topic, and upon review of the terms of reference for the Honorary Degrees and Ceremonial (HD&C) committee, Senate referred the matter to the HD&C committee for consideration, and requested that the committee report back to Senate with guidance on the motion before a vote was to be held.

Senate was then advised that the HD&C Committee undertook extensive and thoughtful consideration of this matter and submits a report with the following recommendations for Senate's consideration:

The Committee on Honorary Degrees and Ceremonial does not support the motion as tabled at the Senate meeting of December 13, 2022. It therefore recommends

that the inclusion of the Provincial Anthem at Convocation ceremonies remain paused and proposes the following alternative courses of action for Senate's consideration

The alternative courses of action for Senate's consideration are as follows:

1. That Senate consult with Indigenous people (students, staff, alumni, members, elders) on their opinions regarding the inclusion of the Provincial Anthem, "Ode to Newfoundland" at Convocation;

2. That Senate engage with members of the university community from Labrador (e.g., faculty, students, staff, alumni), and leaders from Labrador from outside the university community, about how to meaningfully include Labrador in Convocation;

3. That Senate strike an ad hoc committee to engage in these consultations which would include broad representation, with members from within and beyond the university (including Indigenous members of our community) as well as representation from Labrador;

4. That this ad hoc committee also engage with other stakeholders in the university and community (students, faculty, staff, alumni, donors, funders, etc.) on the matter; and

5. After consideration of the findings from these engagements, that Senate then make an informed decision on the Ode's inclusion in Convocation.

Following discussion it was moved and seconded that the original motion of December 13 be rescinded and that Senate accept the report of the HD&C Committee and its recommendations as presented. The motion carried.

#### 102. Report of the Ad hoc Senate Governance Review Committee

Senate received and reviewed the Report of the Ad hoc Senate Governance Review Committee. Ms. Snow, Co-Chair of the Ad Hoc Committee provided an overview of the work of the committee and summarized its findings. The final report to Senate focused on three thematic areas: 1. Solidifying, Renewing and Strengthening the Governance of Senate. 2. Ensuring Senate Equity, Diversity, Inclusion, and Indigenization. 3. Supporting Senate Effectively. Across these three thematic areas the report contains a total of 11 recommendations for consideration and future implementation.

Following a brief discussion by Senators Dr. Kendall, Co-Chair of the Ad Hoc Committee moved to (i) adopt Roberts' Rules of Order, seconded by Dr. MacDonald; (ii) eligibility for membership of Senate, seconded by Dr. Bugden; (iii) speaker of Senate, moved by Dr. MacDonald; and (iv) adopt the Report of the Ad Hoc Senate Governance Review Committee as presented, seconded by Dr. Hardy-Cox, and motion was carried.

The University Governance Secretariat will now commence work to implement these recommendations, and will report back to Senate on the progress as outlined in the attached report.

#### 103. <u>Remarks from the Chair</u>

The Chair provided remarks regarding the *Memorial University Act*. Recently government tabled the First and Second readings of the Bill to amend the *Memorial University Act*. While the University had requested more substantial changes to the Act, it is pleased to see provision being made that could see employees of the University be eligible for appointment to the Board of Regents.

The Chair then provided status updates on several searches for leadership positions including the search for the Vice-President Grenfell Campus and the Provost and Vice-President (Academic) which is hoped to commence with the formation of the search committee soon.

#### 104. <u>Remarks from the Deputy Chair</u>

The Deputy Chair then provided an update on the current searches for the Deans of many faculties including

Education, Business, Human Kinetics and Recreation, Social Work and School of Graduate Studies all of which have active searches underway in various phases. The searches for Deans of the Faculties of Nursing, Science and Engineering and Applied Science will begin at a later date.

Dr. Sutherland informed Senate that the search for the Dean of Science and the Environment is actively underway. The finalists will be announced soon and presentations from those candidates will begin in late May or early June.
