GSU underway to review the Graduate Student Development Fund – students form different societies and the societies are ratified at the AGM. Those societies are

required to provide a yearly report of how the funds were spent. There are currently 29 societies that have been ratified.

There are some events being planned for WinterFest with virtual events planned, but there may also be on-campus events depending on circumstances.

i. Economics

The Department of Economics is requesting approval of revisions to section 9.8.1 of the University Calendar, to remove the requirement that applicants to the MA program must hold a degree from a Canadian University. International students are admitted to the program and would-be applicants might be discouraged by this technicality while considering whether to apply to the program.

9.8.1 Qualifications for Admission

To be considered for admission, an applicant must normally have completed an undergraduate Degree in Economics at a Canadian university with at least second-class Honours standing, or its equivalent. Satisfaction of this criterion does not guarantee admission and, if admitted, students may be required to complete specified undergraduate courses as deemed necessary by the Department.

ii. Folklore

The Department of Folklore is requesting approval of revisions to section 40.16.1, item 2, and 40.16.2 of the University Calendar, which removes the requirement that FOLK 7100 is necessary for completion of the PhD program. The course will continue to be offered, and will remain a requirement for the PhD in Ethnomusicology.

40.16.1 Program of Study

- 1. An applicant for admission to the Ph.D. program in Folklore must hold an M.A. Degree in Folklore, or its equivalent as determined by the Head of the Department and the Dean, with an average grade in M.A. courses of not less than 80%.
- 2. All Ph.D. students in the Folklore program must complete *at least* 18 credit hours in program graduate courses which shall include Folklore 7000 and 7100. Students will normally be free to choose graduate courses of interest to them in Folklore or related disciplines, though it will be a primary responsibility of their committees to ensure that any serious deficiencies are made good. At the end of the second semester the program and further status of the student will be reviewed.

Secondary Calendar Changes

In the listing of graduate courses on the same page, section 40.16.2, the first paragraph would now be as follows:

A selection of the following graduate courses will be offered to meet the requirements of students, normally after consultation with the Head of the Department or the Graduate Studies Administrator, and as far as the resources of the Department will allow. Courses are structured according to the categories of: Theories and Methods, Issues, Form and Performance, Special Topics, Regional, National and International Heritage, Social Identities, Public and Applied Folklore, Interdisciplinary Perspectives and Required (Ph.D.).

The heading for the 7000-level courses would then be "PhD":

Required (Ph.D.)

7000 Advanced Folkloristics I 7100 Advanced Folkloristics II Research and Ethnography

iii. MBA-SEE

The Faculty of Business Administration is requesting approval of revisions to section 12.4 of the MBA-SEE program which changes the credit hours for existing courses Business 8504, 8506, 8507, 8508 from two credit hours to three credit hours, and revises 8517 and 8518 to mandatory non-credit courses.
