a) Equity, Diversity and Inclusion – Anti Racism (EDI-AR)

A.Warren gave an update for information to Council members on EDI-AR forthcoming work by SGS. There was a discussion with members on new programs and how we go forward keeping considerations related to EDI-AR and Indigenization of curriculum a priority for graduate programs. Two members of council noted some issues with how, when and why we conduct consultations, noting we need to be more mindful about this process. When Indigenous groups or individuals are consulted it should not be to simply complete a checklist, it should be meaningful and necessary based on the program being proposed. A. Warren noted that SGS is currently working with experts within Memorial on how best to move forward keeping these issues in mind. In addition, another member spoke about the struggle to get support in trying to navigate courses with Indigenous content. A.Warren noted the need for units to have dedicated resources for Indigenization as well as broader EDI-AR issues. Members also discussed the need for non-traditional pathways to graduate school for Indigenous people. A. Warren noted there is an existing pathway that can assist called Prior Learning Assessment (PLAR).
