 - a. The following items of business on the June 11, 2013 Senate, consent agenda, were approved:

 - b. SGS has very efficient admission practices. Through the Provost office, and with conversations with Deans and Heads of academic

units, there is an enrolment plan that is taking shape. The University is projecting a healthy enrolment, albeit at a recent conference, with approximately 85 countries represented, there was the uneasy feeling of a decrease in undergraduate enrolment. MUN is research intensive which is a very good reason for increasing the graduate body. The enrolment plan will set some specific goals, and how we get there, and the necessary resources to get there, need to be worked out. SGS graduate enrolment is approx 3400, and is aiming for 4500 – 4600 by 2020. SGS is committed to this, and framing such objectives. It also helps that our low tuition is helping to enhance our reputation.

- c. A very successful Graduate Orientation was held September 3rd.
- d. SGS has a monthly newsletter.
- e. SSHRC and NSERC information sessions will be held again this year, at Bitters. Watch for announcement of the dates.

 Dr. Rosemary Ommer, Grants Crafter, will again this year to offer guidance to those preparing grant applications. However, this year she will not be on-site, but rather will be available via email. A notice will be distributed with particular information on her availability during specific dates and times.

5. REPORT OF THE GRADUATE STUDENTS' UNION

- a. The GSU is posting a job opportunity for a second full-time office person Human Resources Manager. Criteria for this position will include, but not limited to, employment relations, business background, with an annual salary of \$45-50,000. This originally started as a Co-ordinator, graduate student position, but is now opening up to a Manager position.
- b. The survey on housing is now closed. The GSU is looking forward to consulting with MUN administration, in regard to The Battery, and what this will mean for graduate students.
- c. The GSU will be holding its semi-annual General Meeting in October.

7.12.1 Program of Study

- 1. Applicants may be admitted to the graduate program if they have an average of at least grade 'B' in no fewer than 36 credit hours in Folklore or in any other discipline in the Humanities or Social Sciences.
- 2. The M.A. program will normally be completed within six consecutive semesters (i.e., a two-year period). The Degree of Master of Arts in Folklore may be taken by course work and comprehensive examination, course work and thesis, or course work and co-operative education work terms. All options are available to full-time and part-time students. However, the work term component of option C cannot be completed on a part-time basis.

a. M.A. With Thesis:

- i. Students choosing to do the M.A. with thesis must normally complete a minimum of 24 credit hours plus a thesis. Normally, the required courses are:
 - 6010, 6020, and 6030, normally taken as an integrated foundation in the Fall semester.
 - At least one of the following: 6060, 6100, 6120, 6130, 6200, 6210, 6220, 6250, 6260, 6360, 6720.
 - At least one of the following: 6070, 6300, 6310, 6350, 6370, 6400, 6410, 6420, 6430.
 - Nine additional credit hours to be selected from courses in the groups listed above or from the other courses offered by

the Department.

ii. A brief thesis pre-proposal, including a statement of topic, working title, plan of research, ethics statement, preliminary bibliography, and the name of a preferred Supervisor, shall be submitted no later than the end of the candidate's second semester. A full proposal shall normally be submitted to the Department of Folklore and orally presented before members of the faculty by the end of the candidate's fourth semester. The written thesis proposal should be made available to faculty members at least two weeks prior to the scheduled date of a student's oral presentation of the proposal. Following approval of the thesis proposal and consultation with the candidate, the Supervisor and thesis topic will be recommended to the Dean.

b. M.A. With Comprehensive Examination:

- i. Students choosing to do the M.A. with comprehensive examination must normally complete a minimum of 30 credit hours plus comprehensive examination. Normally, the required courses are:
 - 6010, 6020, and 6030, normally taken as an integrated foundation in the Fall semester.
 - At least one of the following: 6060, 6100, 6120, 6130, 6200, 6210, 6220, 6250, 6260, 6360, 6720.
 - At least one of the following: 6070, 6300, 6310, 6350, 6370, 6400, 6410, 6420, 6430.
 - Fifteen additional credit hours to be selected from courses in the groups listed above or from the other courses offered by the Department.
- ii. Each candidate selecting the M.A. with comprehensive examination option shall normally submit, by the end of the candidate's second semester, written notification of intention to take comprehensives.
- iii. Each candidate selecting this option shall normally write the comprehensive examination at the end of the candidate's fifth semester in the program. The comprehensive examination will be graded by a comprehensive examination committee appointed by the Dean of Graduate Studies on the recommendation of the Head of the Department, in accordance with **General Regulations** governing the School of Graduate Studies.

c. M.A. With Public and Applied Folklore Co-operative Education Work Terms:

i. Students choosing to do the M.A. with Public and Applied Folklore Co-operative Education option must normally complete a minimum of 24 credit hours plus two co-operative education work terms. The

required courses are:

- 6010, 6020, and 6030, normally taken as in integrated foundation in the Fall semester.
- 6740 or 6800 and at least one additional course selected from the following: 6551, 6740, 6760, 6790, 6800.
- At least one of the following: <u>6060</u>, 6100, 6120, 6130, 6200, 6210, 6220, 6250, 6260, 6360, 6720.
- At least one of the following <u>6070</u>, 6300, 6310, 6350, 6370, 6400, 6410, 6420, 6430.
- Three additional credit hours to be selected from courses in the groups listed above or from the other courses offered by the Department.
- 601W and 602W.

30.14.1 Program of Study

- 4. Comprehensive Examination for the Ph.D.:
 - The Ph.D. Comprehensive Examination shall be administered a. in accordance with General Regulations, Comprehensive **Examinations.** Candidates will prepare for three examinations by undertaking supervised readings in three fields decided by the Comprehensive Examinations Committee. The basic principle is to integrate knowledge within specific areas of folklore and folklife scholarship. The examination normally will be written with the format to be determined by the Comprehensive Examination Committee in consultation with the student. Assessment will be based on the examination of three papers each of one week duration or three elosed open book examinations each of eight hour duration. The Committee will recommend to the Dean of Graduate Studies a grade of PAS (pass), FAL (fail), or PWD (pass with distinction).
- ii) Faculty of Education Calendar Revisions

It was moved by Dr. Behm, and seconded by Dr. Sheppard, that the proposed changes to make existing courses 7001 and 7002 into linked courses, 701/A/B and 702A/B, be approved.

Discussion:

It was noted that there should be some minor revisions to the package before it is forwarded to Senate Executive for consideration:

- Insert 701A/B and 702A/B on one form (having 701A and 701B on separate forms implies they are two separate courses.
- List 701 A/B under Courses section (no need to indicate 0 credits for 701A if being listed as 701 A/B).
- Under 30.9.3.1.a. insert notation that indicates when students will register for the 'A' and 'B' portions, and indicate that a grade of NC (No Grade Expected) will be assigned to the 'A' portion of each of these courses.
- A note needs to be inserted under the Courses section to reference the credit restrictions for 7001 and 7002.
- A grading scheme for 701A/B is required.

b. Based on a consideration of educational background and research interest, students may be required to complete (or have completed at the

masters level) as many as two (2) additional courses in research related to their program focus and specialty.
