Course Title: Social Work Philosophy and Practice

Course Schedule: Online Course (Undergraduate lecture period: January 4, 2024 – April 5, 2024)

Campus Location: Distance Education - Online/asynchronous teaching and learning

Campus Location: St. John's College

Course #: Social Work 3720-002

Course Title: Ethical and Legal Issues in Social Work Practice

Course Schedule: Mondays 2:00 PM - 5:00 PM (Undergraduate lecture period: January 4, 2024 - April 5, 2024)

Campus Location: St. John's College

Course Description: Ethical and Legal Issues in Social Work Practice examines ethical theories, decision-making models and key legislation in a variety of areas including child welfare, youth justice, privacy, health, and human rights to resolve dilemmas in practice. Components of legislation and the Social Work Code of Ethics are analysed to determine approaches to practice dilemmas. Consideration and critical analysis of frameworks for decision making will lead to a personal model for practice choices.

**Required Knowledge, Skills, and Qualifications:** Demonstrated understanding and effective application of ethical theories and principles in a variety of practical contexts when dealing with moral issues, ethical reasoning, and legal decision-making.

- A minimum of 5 years' experience in social work, with demonstrated understanding and application of ethical theories and principles across broad practice areas in discussions of moral issues, ethical reasoning, and legal judgement in practice; and

Course #: Social Work 4521-700 (NAC-BSW Program)

Course Title: Social Work Organizational Development for Community Services

Course Schedule: Three (3) Week Period – Monday, March 18 to Friday, April 5, 2024, 9:00 AM – 12:00 PM

Campus Location: Nunavut Arctic College, Cambridge Bay, NT

Course Description: Social Work Organizational Development for Community Services examines policy development and change in human services organizations and their administration. Management and organizational concepts suitable for the administration of social policies and programs are addressed as are ethical and ideological issues for social workers on human service teams. A focus on beginning skills in administration is included for the social worker within a management and leadership context in human services organizations.

Required Knowledge, Skills, and Qualifications: Possess expertise in leadership, change management, and team dynamics with practical application of organizational theories and concepts in human services settings, fostering growth and efficiency.

- Possess knowledge and experience working with Inuit in the areas of organizational development and community services; social work practice must be consistent with Inuit Qaujimajatuqangit (IQ) Principles
- Include a focus on Inuit and other Indigenous ways of knowing and being in teaching and course materials
- Previous teaching experience at the post-secondary level; and
- Be a registered Social Worker

Course Title: Leadership in Social Policy and Programs

Course Schedule: Online Course (Graduate Lecture Period: January 4, 2024 – April 5, 2024)

Campus Location: Distance Education - Online/asynchronous teaching and learning

Course Description: Leadership in Social Policy and Programs focuses on frameworks to develop, analyze and evaluate social policies and programs. The course prepares students to demonstrate the knowledge and skills expected within the context of professional judgements, and competent professional action in evaluating social policies and social programs. The conceptual base is interdisciplinary with particular attention to the research skills in the evaluation of policies and programs consistent within the social work traditions in community, private, governmental, and not for profit sectors.

**Required Knowledge, Skills, and Qualifications:** Have practical experience in public administration, government organizations, or non-profit sectors, particularly in leadership, program management, or policy development roles; be able to develop, implement, and evaluate policies across a variety of practice areas; have a solid grasp of leadership concepts, strategies, and styles in the context of public and social policy.

- A minimum of 5 years' experience in social work, preferably in leadership, with practical knowledge of social policies and programs; and
